**REVIEW OF THE AGENDA OF THE LEGAL COMMISSION  
OF THE 39TH SESSION OF THE ASSEMBLY**

**1. INTRODUCTION**

1.1 The Council at the third meeting during its 205th Session, while considering the Draft Provisional Agenda for the 39th Session of the ICAO Assembly (2016), decided to refer the Agenda Items and notes for the Legal Commission to the Legal Committee for consideration during its 36th Session and report to the Council. The 39th Session of the ICAO Assembly will be held on 27 September to 7 October 2016.

**2. AGENDA ITEMS AND NOTES**

2.1 The Agenda Items and notes for the Legal Commission are set out below:

**LEGAL COMMISSION**

**Item L1: Annual Reports of the Council to the Assembly for 2013, 2014 and 2015**

The Legal Commission will be invited to review those parts of the Annual Reports of the Council to the Assembly for 2013, 2014 and 2015 and the supplementary report covering the first six months of 2016 falling within its field of competence.

**Item L2: Work programme of the Organization in the legal field**

The Council will present a report on the progress of work in relation to the items on the work programme of the Legal Committee and will present recommendations for the future work programme as appropriate.

**Item L3: Consolidated statement of continuing ICAO policies in the legal field**

The Council will present proposals for updating the Consolidated statement of continuing ICAO policies in the legal field (Assembly Resolution A37-22).

**Item L4: Other issues to be considered by the Legal Commission**

This item is intended for subjects concerning issues other than those that have a specific agenda item, which require the consideration of the Assembly.

2.2 The provisional agenda prepared by the Council is communicated to Contracting States and approved by the Assembly after the opening of the session (Rules 10 and 12, *Standing Rules of Procedure of the Assembly of the International Civil Aviation Organization*, Doc 7600).

2.3 In considering this item, the Legal Committee is expected to examine the agenda and determine whether all the subjects are appropriate for submission to the Assembly or whether any additions or modifications are desirable. The items listed in paragraph 2.1 above are standard subjects normally included in the provisional agenda of the Legal Commission for past sessions of the Assembly.

**3. ACTION BY THE COMMITTEE**

3.1 The Legal Committee is invited to consider this working paper and confirm items L1, L2, L3 and L4 and corresponding notes for inclusion in the draft Provisional Agenda of the 39th Session of the Assembly.
