## 3. PROCEEDINGS ON 24 NOVEMBER 2009

### 3.1 Morning session

3.1.1 Deliberations of Agenda item 2 — Air Carrier Traffic Data and Traffic Flow Statistics Regular session continued on the basis of the following working papers, listed in the order in which they were presented by the Secretariat: WP/8 — Review of On-flight Origin and Destination (OFOD) Publication Rules and Data, WP/9 — Definition and Identification of Low-Cost Carriers and WP/10 — Quick Monitoring System (QMS) of Commercial Air Carrier Monthly Traffic Data.

3.1.2 Deliberations of Agenda item 3 — Air Carrier Financial Data were carried on the basis of WP/11 — Quick Monitoring System (QMS) of Commercial Air Carrier Financial and WP/12 — Impact of Reporting of Air Carrier Financial Data on Traffic Forecasts – Surcharges.

3.1.3 Deliberations of Agenda item 4 — Airport Traffic Data were carried on the basis of: WP/13 — Review of Airport Traffic Data, WP/14 — Data Requirements for Forecasting Activities and WP/15 — Collection of Data on Airport and Airspace Capacity, Investment and Funding.
