The Collection is recommended for use by State authorities because it illustrates international procurement best practices and details each step in the procurement process.

Procurement projects are often large, complex and consist of a multitude of discrete tasks to be completed within pre-planned timeframes.

Those seeking to embark on a procurement process for MRTD systems should be aware of the pitfalls and obstacles involved in such ventures and how to design the procurement process to mitigate or prevent problems before they occur.

The Collection outlines the principles of procurement that should be considered before the project commences and then describes the procurement process:

- define the needs of the project
- the tender process
- bid evaluation
- contract award; and
- managing change.





