## **Mohamed Rahma**

*Director, Air Transport Bureau, ICAO*

Mr. Mohamed Khalifa Rahma assumed his position as Director, Air Transport Bureau, of the International Civil Aviation Organization (ICAO) in April 2020. Before his appointment, Mr. Rahma was the Regional Director of the ICAO Middle East Regional Office since March 2016. The current work portfolio of Mr. Rahma covers a wide range of global aviation domain including Air Transport, Aviation Security and Facilitation and Environmental protection. He is currently the Secretary of the Council Aviation Recovery Task Force (CART). During his tenure in ICAO Middle East Office, he was instrumental in strengthening regional and inter-regional collaboration in aviation industry. This effort included enhancing risk awareness and response, promoting technologies while fostering new innovations, and improving oversight and quality assurance. Mr. Rahma continues to significantly increase cooperation among member States, international and Regional organizations. Prior to Joining ICAO, Mr. Rahma was the Undersecretary of International and Internal Affairs at the Ministry of Civil Aviation of Egypt and previously the advisor to the Egyptian Minister of Civi Aviation. During his tenure at the Egyptian government, Mr. Rahma played a substantial role and led influential projects that actively supported and enhanced aviation capacity and efficiency in Egypt. He developed cooperative relationships with government bodies and investors while paving the way for future business partnerships and opportunities. Mr. Rahma was a board member of various companies including Cairo Airport Company, Aerotel Company and EMAC Aqaba Company and chaired many strategic committees under the umbrella of the Ministry of Civil Aviation for special projects. He led and participated in many high level national and regional committees. Mr. Rahma has 30 years of aviation experience in various fields including aviation management, airline management, operation, safety, training, corporate communication, and crisis management. He holds a Master's Degree in Aviation Management and speaks fluent English and Arabic.



**Salvatore Sciacchitano**  
*President of the ICAO Council*

Mr. Salvatore Sciacchitano is the sixth President of the ICAO Council. He succeeded Dr. Olumuyiwa Benard Aliu on 1 January 2020.

Mr Sciacchitano graduated in Telecommunications Engineering from the University of Catania and began his career in aviation in 1980, joining the Italian Airworthiness Authority (RAI) where he held positions of increasing responsibility, serving as the organization's Regulation Director in 1992, then as Technical Director and, in 1996, as Director General.

With the merger of the aviation branch of the Ministry of Transport and RAI and the subsequent establishment of the Italian Civil Aviation Authority (ENAC), Mr. Sciacchitano assumed the position of Deputy Director General. In this position, he played an instrumental role in coordinating the core business divisions of the newly founded structure. He was also entrusted with multiple international mandates, chairing the Permanent Commission of EUROCONTROL, representing Italy in the Management Board of European Aviation Safety Agency (EASA), holding the Vice-Presidency of the EUROCONTROL Provisional Council and coordinating the Italian delegation during ICAO Assemblies.

As a result of his extensive experience in aviation international affairs, Mr. Sciacchitano was appointed Executive Secretary of the European Civil Aviation Conference (ECAC) in 2010. In February 2019, he joined the Italian Delegation on the Council of ICAO, where he served until assuming his duties as President of the Council.



## **Ambassador Isao Fukushima**

*Representative on the Council of ICAO, Japan*

Ambassador Isao Fukushima has been the Representative of Japan on the Council of the International Civil Aviation Organization (ICAO) since November 2019.

He joined the Ministry of Foreign Affairs of Japan (MOFA) in 1984. Prior to his assignment at ICAO, he served as the Special Coordinator responsible for recruitment and human resources in the Minister's Secretariat.

Between 2012 and 2015 he served as the Senior Coordinator for International Nuclear Cooperation, particularly negotiating bilateral agreements. In his previous diplomatic posts, he engaged in economic cooperation with African countries, and worked on cultural exchange and International Law and Treaties.

In addition, he worked for the Embassy of Japan in the Former Republic of Zaire (Democratic Republic of the Congo) and the Embassy of Japan in France. He later served as the Secretary-General for the Japan Cultural Institute in Paris for 3 years.



## **Douglas Yeo**

*Acting Chair, Facilitation Panel & Director, Security Policy & Emergency Preparedness, International Relations & Security Division, Ministry of Transport, Singapore President of the ICAO Council*

Douglas Yeo is the Director for Security Policy and Emergency Preparedness with the Ministry of Transport, Singapore. His team oversees all aspects of Land, Air and Maritime transport security policies, including cybersecurity and emergency preparedness.

Prior to joining the Ministry, Douglas had served as the Deputy Director for Aviation Security and Emergency Preparedness with the Civil Aviation Authority of Singapore, as well as with the Singapore Police Force. In his 20 years of service with the Singapore Police Force, Douglas saw duty in a range of roles spanning command, investigations and operations in various police units. Douglas left the Singapore Police Force with the rank of Superintendent of Police and was at that time in-charge of aviation security and quality control with the Airport Police Division.

Douglas led Singapore's effort in developing and implementing an air cargo supply chain security regime. He was also instrumental in developing and implementing Singapore's national civil aviation security quality control programme, as well as fronting Singapore's compliance efforts for both the 2006 and 2012 Universal Security Audit Programme conducted by the International Civil Aviation Organisation.

Douglas is the Vice-Chair of the ICAO Facilitation Panel and Singapore's representative on the Panel. He is also Singapore's alternate representative for the ICAO Aviation Security Panel, and Chair of the ICAO Asia and Pacific Regional Aviation Security Coordination Forum (RASCF). He also currently chairs the Aviation Security & Facilitation sub-group of the ICAO APAC COVID-19 Contingency and Recovery Planning Group. Douglas is the Rapporteur of the ICAO Facilitation Panel's Working Group on Guidance Material, acting in this capacity since 2016.

Douglas graduated in 1993 with a Honours degree in Economics and holds professional qualifications as an Avsec Professional Manager, ICAO Certified Avsec Instructor and ICAO Certified USAP Auditor.

- conducting audits of Member States' aviation security and border security activities,
- assisting States in addressing deficiencies highlighted by needs assessments and audits, and
- supporting the implementation of the Global Aviation Security Plan (GASeP), the Traveler Identification Programme (ICAO TRIP) Strategy and the Cybersecurity action plan for civil aviation (CYSAP).

Sylvain is secretary of the Aviation Security Committee, the International Explosives Technical Commission, the Aviation Security Panel, and the Cyber Security Panel.

Before ICAO, Sylvain's career spans more than 25 years in the French ministry of transports, covering transport safety and security in maritime navigation, ground transportation and air navigation.

He is the National Coordinator for the ICAO Universal Security Audit Programme and was also recently nominated as the National Focal Point for Aviation Security to the Organization of American States. Along with his international duties, Antonio is responsible for ensuring that all regulated aviation and aviation-connected entities, operating in and to the Bahamas, comply with the Bahamas Civil Act, the National Aviation Security Programme, and all applicable aviation security policy in the Bahamas. He also manages the daily operations of the CAAB Aviation Security and Facilitation Oversight Department.

Previously, Antonio was an air traffic controller at the Lynden Pindling International Airport for more than 17 years. He is also a certified aerodrome controller, instructor and evaluator. When joining ICAO in 2008, Dr Abdennebi was appointed as Chief Economic Analysis and Policy Section, responsible during 7 years for matters related to air transport regulation, economics of airports and air navigation services, aviation data and economic studies of ICAO, enabling the monitoring of the Strategic Objectives of the Organization.

Prior to this appointment, Mrs Abdennebi has held a variety of marketing, sales and market research positions in the air transport industry, notably in a regional air carrier and in Airbus where she worked for over seven years.

She holds a PhD degree in air transport economics from the Cranfield University, a degree in Aeronautical Engineering from a French school, Ecole Nationale de l'Aviation Civile (Toulouse), as well as a Research Masters degree in transport Economics from Ecole des Ponts Paris Tech and a Masters degree in air transport management from the business school ESC (Toulouse).


**Sanjay Dharwadker**  
*Digital Identity Expert*

Sanjay Dharwadker is the Senior Digital Identity Officer in the Office of the United Nations High Commissioner for Refugees (UNHCR). He also works on global identity standards at ISO (SC17-ID documents, SC27-IT security and SC-37 biometrics) as well as the New technology Working Group (NTWG) and the Implementation and Capacity Building Working Group (ICBWG) of the International Civil Aviation Organization (ICAO).

His current focus areas include civil registration, evidence of identity, electronic travel authorization, vaccine certification, data protection, biometrics and biographics.

Sanjay Dharwadker has over 3 decades of experience in the field of identity and identification with assignments in Asia (1989 – 2004), Africa (2004 – 2014) and Europe (since 2014) which includes working with a number of national governments, UNHCR, UNICEF and the World Bank.

He is a participant at The Hague Colloquium on the future of legal identity and writes regularly on the subject.



## **Andrew Hopkins**

*Chief, Identity Management and Registration Section, United Nations High Commissioner for Refugees (UNHCR)*

Andrew Hopkins is the Chief of the Digital Identity and Registration Section with the United Nations High Commissioner for Refugees based in its Global Data Service, Copenhagen. He has over 30 years' experience in managing refugee programs and currently leads the organization's global digital identity and registration efforts to ensure refugee identities are anchored and maintained within a system of inclusivity.

Mr. Hopkins has worked in a wide range of challenging environments that most governments or law enforcement agencies would not normally encounter. He began his refugee work over 30 years ago at the US Orderly Departure Program, managing the resettlement of Vietnamese refugees in South-East Asia and later leveraged his knowledge to design and manage large-scale refugee resettlement projects in Asia and Africa. In subsequent assignments, Mr. Hopkins co-authored UNHCR's guidance on registration and identity management and contributed to designing and rolling out proGres, UNHCR's registration, documentation and case management software. The system now contains data on over 23 million persons of concern and is deployed in 122 countries worldwide.

Mr. Hopkins has led the development and resourcing of registration activities to support UNHCR's emergency response in many forced displacement contexts including, most recently, to facilitate the rapid delivery of much-needed cash to Ukraine refugee families seeking support in western Europe.

He is passionate about ensuring UNHCR leads on the responsible and ethical use of personal data, and firmly believes that UNHCR's identity management work improves inclusion and empowerment for the world's most vulnerable.



**Muhammad Tariq Malik**  
*Chairman, NADRA, Pakistan*

Muhammad Tariq Malik, was appointed as Chairman of the National Database and Registration Authority (NADRA), Pakistan.

Before his appointment in NADRA he was working as Chief Technical Advisor, United Nations Development Program (UNDP) where he was advising on 'Digital Governance' to 130+ member states across five regions spread over worldwide. Prior to joining UNDP, he served World Bank as a Senior Technical Consultant. He was a member of the core team who helped to initiate the worldwide 'ID for Development' (#ID4D) Program as well as authored the framework of international standards for digital identity. His name was included in the World's 100 Most Influential People in 'Digital Government' by a European think tank known as Apolitical. Before joining World Bank Malik helped various governments to optimize use of Big Data and advanced data analytics from the platform of Teradata Inc. Malik worked on a multi-biometric system resulting in registration of more than 121 million citizens along their associated biometric attributes.

Tariq led similar projects and development based interventions in USA, Kenya, Nigeria, Sri Lanka, Bahrain, Bangladesh, Russia, Malawi and Tanzania. He helped various institutions of United Nations (UNHCR, ICAO, UNDP) and World Bank (Poverty Score Card, BISP, Disaster Management and ID Ecosystem), to accomplish development goals with transparency. Throughout his career, Malik has helped governments to improve service delivery using innovative technologies. Result-based achievements earned him various national and international awards. Malik holds Master's degrees in both International Management (Heidelberg, Germany) and Computer Science (QAU Islamabad). His Bachelor's degree is in Mathematics and statistics. He was trained at the JFK School of Government, Harvard University and Stanford University. Malik's articles are published in National and International Publications.



## Alexander Schuster

Alexander Schuster holds a dual doctorate from Trento and from Strasbourg University (mention très bien avec félicitations) and a diploma from the European Public Law Organisation. In 2021, the 8th edition of Doc 9303 was published. This year special attention was given to the working relation and processes between ICAO and ISO. Apart from his role in ISO, Joost is Manager Innovation for IDEMIA Public Security & Identity in The Netherlands, leading a dedicated team of experts in the field of traveler identification.

With special interest, Joost and his team participate in digital traveler identity programs with Governments, universities and industry partners. Always keeping an eye on interoperability and compliancy to international standards. Joost lives in Haarlem with his family, is a proud father of an 11-year-old daughter and a 4-year-old son. He has recently been voted to the Chair of the International Civil Aviation Organization (ICAO) Implementation and Capacity Building Working Group (ICBWG), having been Secretary since its formation in 2008. Dion represents New Zealand on the ICAO Facilitation Panel (FAL) and Technical Advisory Group for Traveller Identification (TAG-TRIP). He also leads the policy sub-group for the development of the Digital Travel Credential, and the Data Minimisation sub-group – both part of the ICAO New Technologies Working Group (NTWG)

Dion is on the Board of Directors for the Biometrics Institute, and his team is responsible for contributing to ISO SC17 (Cards and Security Devices for Personal Identification) and SC37 (Biometrics) technical standards working groups. Dion has also led assistance and capacity building missions in the South Pacific, focussing on the implementation of new passport and civil registration systems, and supporting legislative and operational policy change in developing nations.
