PROPUESTA DE HOJA DE RUTA PARA FORTALECER LA SEGURIDAD MUNDIAL DE LA CARGA AÉREA

(Nota presentada por Alemania, Arabia Saudita, Australia, Bélgica, Canadá, China, Estados Unidos, Federación de Rusia, Japón, Jordania, Líbano, Nueva Zelanda, Reino Unido, Senegal, Singapur, Sudáfrica, Suiza, Consejo Internacional de Aeropuertos, Asociación Global Express, Asociación del Transporte Aéreo Internacional, Asociación Internacional de Carga Aérea, Unión Postal Universal y Organización Mundial de Aduanas)

RESUMEN

Para apoyar la función de la OACI en el mejoramiento de la seguridad de la carga aérea, el Grupo de trabajo sobre seguridad de la carga aérea (WGACS) del Grupo de expertos sobre seguridad de la aviación ha elaborado una hoja de ruta que articula actividades fundamentales emprendidas por partes interesadas internacionales y contribuciones hacia el fortalecimiento de la seguridad mundial de la carga aérea frente a las amenazas de interferencia ilícita.¹ Las iniciativas se identifican dentro de amplias áreas de acción con referencia a las estrategias primordiales pertinentes articuladas en la Estrategia global de la OACI sobre seguridad de la aviación (ICASS) (véase A38-WP/13).

Decisión de la Asamblea: Se invita a la Asamblea a que respalde la hoja de ruta para fortalecer la seguridad mundial de la carga aérea como marco general de las actividades en marcha y convenga en que se actualice continuamente para reflejar las más recientes novedades.

1. INTRODUCCIÓN

1.1 El complot del 29 de octubre de 2010 para introducir artefactos explosivos improvisados (IED) en la cadena de suministros de la carga aérea ilustró las vulnerabilidades del sistema mundial de seguridad de la carga aérea, que fueron explotadas por terroristas. El complot puso de manifiesto la necesidad de contar con medidas de colaboración de los Estados miembros para fortalecer las actuales medidas de seguridad de la carga aérea de forma que sean coordinadas y rigurosamente aplicadas internacionalmente, así como coherentes y prácticas, sin afectar negativamente al comercio internacional.

1.2 Desde 2010, los Estados miembros y las partes interesadas de la aviación han trabajado en forma diligente para formar una visión contemporánea de la amenaza contra la seguridad de la carga aérea y las formas más eficaces de fortalecer los controles de seguridad para mitigar dicha amenaza. El grupo de trabajo sobre seguridad de la carga aérea (WGACS) del Grupo de expertos sobre la seguridad de la aviación se constituyó en abril de 2011 y está integrado por representantes de Estados miembros, organizaciones como la Organización Mundial de Aduanas y la Unión Postal Universal y órganos de la industria como la Asociación del Transporte Aéreo Internacional y la Asociación Global Express.

1.3 Con más de cinco reuniones desde junio de 2011, el Grupo de expertos sobre seguridad de la aviación ha trabajado a través del WGACS, así como con su grupo de trabajo sobre el Anexo 17 y su grupo de trabajo sobre textos de orientación, con interesados clave en esfuerzos de colaboración tendientes a mejorar la seguridad de la carga aérea, incluyendo el fortalecimiento de normas y métodos recomendados (SARPS) básicos sobre seguridad.

1.4 La Conferencia de alto nivel sobre seguridad de la aviación, de la OACI, celebrada del 12 al 14 de septiembre de 2012 en Montreal, adoptó y respaldó un conjunto de principios sobre seguridad de la carga aérea y del correo, para constituir una piedra fundamental para la adopción de medidas por parte de la OACI y de todos los interesados a efectos de asegurar la cadena de suministros de la carga aérea y del correo. Con posterioridad, el 15 de julio de 2013, entró en vigor la Enmienda 13 de las *Normas y métodos recomendados internacionales — Seguridad de la aviación — Protección de la aviación civil internacional contra actos de interferencia ilícita (Anexo 17 al Convenio sobre Aviación Civil Internacional)*, que incluyó principalmente SARPS relativos a la seguridad de la carga aérea, enmienda acompañada del correspondiente nuevo texto de orientación en la Enmienda 1 de la octava edición del *Manual de seguridad de la aviación* (Documento 8973/8).

1.5 El fortalecimiento del marco de seguridad mundial de la carga aérea es una tarea de múltiples facetas que debería considerar no solamente las normas reglamentarias, los métodos recomendados y la orientación convencionales sino también herramientas mejoradas como los desarrollos tecnológicos y la información. Los Estados miembros, observadores e interesados clave, tanto a título individual como en colaboración, continúan avanzando en una considerable labor para mejorar los resultados en materia de seguridad de la carga aérea a través de una diversa gama de actividades. Estas comprenden la afinación de normas y documentos de orientación, la impartición de instrucción, ofertas y participación para la creación de capacidad, la búsqueda de oportunidades para alinear y armonizar requisitos y la elaboración de tecnología, herramientas y técnicas avanzadas de evaluación de riesgos.

1.6 Si bien la labor inicial ya ha producido buenos resultados es importante que los interesados permanezcan comprometidos en el procedimiento de continuar fortaleciendo los arreglos de seguridad de la carga aérea. Luego de la introducción de enmiendas de normas y procesos, la concentración principal en los meses venideros debería darse en la aplicación coordinada de esas medidas.

2. HOJA DE RUTA

2.1 Para reunir toda esta labor y en apoyo de la dirección política de la Conferencia de alto nivel sobre seguridad de la aviación de la OACI en cuanto al mejoramiento de la seguridad de la carga aérea (véase A38-WP/12), el WGACS ha elaborado la Hoja de ruta (“Roadmap”) para fortalecer la seguridad mundial de la carga aérea, que figura en el Apéndice A (en inglés únicamente).

2.2 En la hoja de ruta se articulan actividades clave emprendidas por partes interesadas internacionales así como contribuciones al fortalecimiento de la seguridad mundial de la carga aérea frente a las amenazas de interferencia ilícita. Las iniciativas se identifican dentro de amplias zonas de acción a que se hace referencia en las estrategias primordiales de la Estrategia global de la OACI sobre seguridad de la aviación (ICASS) (véase A38-WP/13). La hoja de ruta también se ajusta a los principios sobre seguridad de la carga aérea y del correo.

2.3 La finalidad de la hoja de ruta es:

- a) articular con claridad el enfoque multifacético que se está aplicando a través de un complejo sistema con múltiples participantes;
- b) identificar relaciones, sinergias y oportunidades para la colaboración internacional;
- c) promover un entendimiento de las funciones y responsabilidades, a menudo interconectadas, que todas las partes interesadas desempeñan; y
- d) fomentar el impulso continuo del proceso identificando la condición de las actividades y alentando la planificación para el futuro.

2.4 La hoja de ruta es un documento “viviente” que será examinado y actualizado periódicamente para reflejar los progresos en la materia.

2.5 Se invita a la Asamblea a respaldar la Hoja de ruta para fortalecer la seguridad mundial de la carga aérea como marco general de las actividades en marcha y convenir en que se actualice continuamente para reflejar las novedades más recientes.

APPENDIX

ROADMAP TO STRENGTHEN GLOBAL AIR CARGO SECURITY

The Roadmap articulates the key activities underway or completed by international stakeholders that contribute to a strengthening of global air cargo security outcomes. Its purpose is to:

- a) clearly articulate the multi-faceted solution being progressed across a complex system with multiple stakeholders;
- b) identify linkages, synergies and opportunities for international collaboration;
- c) promote an understanding of the roles and responsibilities that all stakeholders play; and
- d) encourage momentum in the process by identifying status of activities and encouraging forward planning.

This Roadmap should be reviewed periodically to reflect new and progressing activities.

This Roadmap is applicable to air cargo and mail security. For the purpose of brevity the generally refers to air cargo with some specific references to mail. References to air cargo should be taken to include mail.

Overarching Goal A global air cargo system that is more secure against the threat of unlawful interference.
