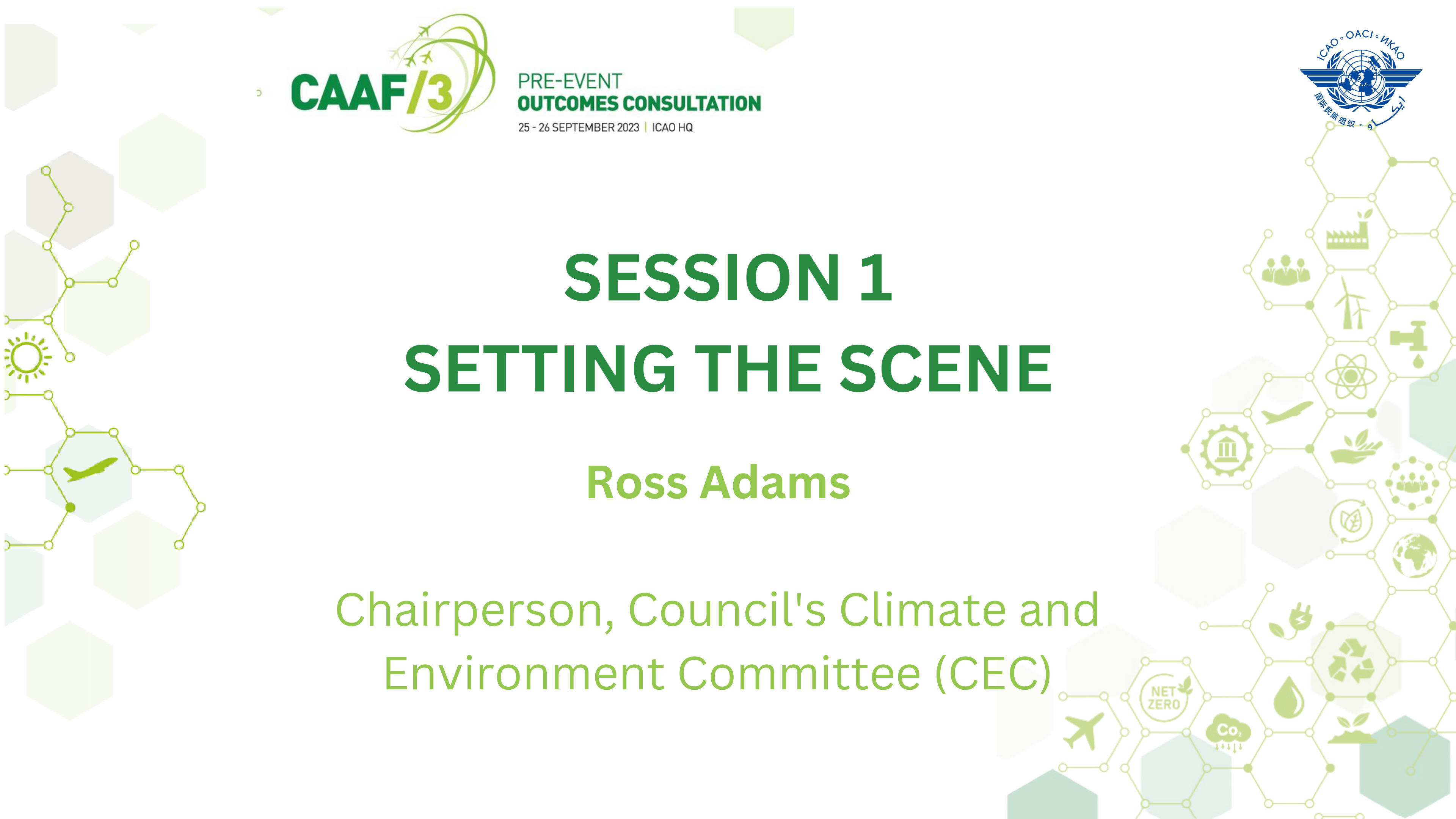

Role of Council CEC's Small Group on Preparation of CAAF/3:

Since early 2023, a Small Group for Preparations for CAAF/3, under the Climate and Environment Committee (CEC) of the Council, has been:

- supporting the preparatory process towards CAAF/3; and
- considering possible CAAF/3 outcomes, including a draft ICAO global framework, taking into account the feedback and input received from various outreach and preparatory activities.

The possible CAAF/3 outcomes, including a draft ICAO global framework, is the reflection of where the CEC Small Group discussions had reached as at the end of August 2023



Draft possible CAAF/3 outcomes, including draft ICAO Global Framework for SAF, LCAF and other Aviation Cleaner Energies:

- To facilitate discussions in the pre-CAAF/3 outcomes consultation event, by providing a draft structure and ideas for the ICAO global framework, which States and Organizations can consider and provide their views.
- It is a work-in-progress developed, and has been developed in the course of discussions by the ICAO Council CEC's Small Group for Preparations of CAAF/3.
- Guided by four building blocks: 1) policy and planning; 2) regulatory framework; 3) implementation support; and 4) financing.



What this document IS

- The draft is a reflection of what the CEC Small Group discussions have reached at this point, and substantial progress has been made in bringing the text to this point.

What this document IS NOT

- The draft should not be considered as settled or agreed ‘text’, nor should it be seen to represent the views of States in the Small Group, either individually or collectively, as it is simply a reflection of where the Small Group discussions have reached at this point.

There are still some areas of the global framework where the Small Group have significant divergence of views.

Broadly, the key points of differences, highlighted in yellow in the draft Global Framework, centre around:

- **a Vision for aviation cleaner energies** (Paragraphs 1-3);
- **accounting methodologies for aviation cleaner energies** (Paragraphs 14-15); and
- **financing for aviation cleaner energies** (Paragraphs 25-39)
