1. Introducción

1.1 La Sede de la OACI ha notificado que recibe pocas respuestas en general a las Comunicaciones a los Estados por parte de los Estados contratantes. El **Apéndice** adjunta la lista de Comunicaciones a los Estados de 2014 a la fecha para facilitar la identificación de cuáles aún no han sido respondidas por los Estados C/CAR.

1.2 En un esfuerzo para mitigar esta situación, la Oficina Regional NACC de la OACI recomendará a la Sede de la OACI categorizar cada Comunicación a los Estados para mostrar su nivel de prioridad, así como otras acciones para mejorar el proceso, promover una mejor tasa de respuesta y minimizar la carga de recursos de los Estados relacionada con este asunto.
