- 1.1 At the Fifth meeting of the AVSEC/FAL Regional Group, Bolivia took on the task of working towards the development of training material that could serve as a guide for the States, taking into account the lack of training material on the subject.
- 1.2 At the Sixth meeting of the AVSEC/FAL Regional Group, Bolivia presented the conventional material it had developed, which was considered as a "best practice" to be used as reference by the States.

1.3 At the Eighth meeting of the AVSEC/FAL Regional Group, Bolivia presented improved material, with guides for instructors and students. The Regional Group validated the material as official training material in Spanish. However, and taking into account that the Regional Group also had English-speaking States, Bolivia took on the task of translating the aforementioned material.

2.1 Since assuming this commitment, Bolivia has been working in the translation of the document into English, which is officially presented to the Secretariat at the Ninth meeting of the AVSEC/FAL Regional Group.
