In support of the E/CAR/NTG, E/CAR/RD and E/CAR/CATG implementation groups, I wish to invite your Administration/Organization to participate in the Tenth Eastern Caribbean Network Technical Group (E/CAR/NTG/10) and Eighth Eastern Caribbean Radar Data Sharing Ad Hoc Group (E/CAR/RD/8) Meetings, to be held online from 6 to 7 September 2021 and to the Fifth Eastern Caribbean Civil Aviation Technical Group (E/CAR/CATG/5) to be held online from 8 to 10 September 2021.

The E/CAR/CATG/5 Meeting will follow-up on the implementation of E/CAR air navigation matters to contribute in the accomplishment of the CAR Air Navigation Services (ANS) Regional plan, and review the E/CAR Region progress based on the results of the NAM/CAR Air Navigation Implementation Working Group (NACC/WG) meeting and update the ECAR/CATG action plan according to the NACC/WG objectives.

For this Meeting, the E/CAR Air Navigation Service Providers (ANSP) and Civil Aviation Authorities (CAA) members are expected to attend, specifically personnel from different air navigation areas such as AIM, AGA, ATM, CNS and MET.

All members of the E/CAR/NTG, E/CAR/RD and E/CAR/CATG are expected to participate.
