The activities of the NCMC Group paused since the last NCMC teleconference in February 2020 will be resumed. In this sense, following the work of the Universal Safety Oversight Audit Programme (USOAP) NCMC Group, I wish to invite your Administration and, in particular, your State's National Continuous Monitoring Coordinators (NCMCs), to participate in the Fourth Regional Meeting for National Continuous Monitoring Coordinators (NCMC/4) to be convened online on 27 September 2021, from 10:00 AM to 2:00 PM hours CDT (15:00 hrs. Working papers received in this office <u>after</u> that date will have to be submitted in both languages. Otherwise, they will become Information Papers. Information papers will only be issued in the language submitted. Papers received from international organizations will not be translated and will be issued only in the language submitted. The deadline to receive papers is <u>20 September 2021</u>. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages (i.e., English and Spanish).
