The Harmonization of the Regulatory Framework Project, presented at ICAO Virtual Meeting for Civil Aviation Authorities Directors General On Aviation Recovery in the North American, Central American and Caribbean (NACC) States held On 15 December 2020, will provide a regional regulatory harmonization mechanism to update State legislation and standards, as well as the creation of a system to support recognition and delegation of authority to inspectors in order to assist other States in their safety oversight obligations implementation.

This scheme of harmonised regulations will also help industry by facilitating international operations, and greater cohesion among aviation actors.
