Dear Sir/Madam,

In support of the Eastern Caribbean Network Technical Group (E/CAR/NTG), the Eastern Caribbean Radar Data Sharing Ad-hoc Group (E/CAR/RD), and the Eastern Caribbean Civil Aviation Technical Group (E/CAR/CATG), I wish to invite your Administration/Organization to participate in the Eleventh Eastern Caribbean Network Technical Group Meeting (E/CAR/NTG/11) the Ninth Eastern Caribbean Radar Data Sharing Ad Hoc Group (E/CAR/RD/8) Meetings, to be held online from 15 to 16 August 2022, and to the Sixth Eastern Caribbean Civil Aviation Technical Group (E/CAR/CATG/6), equally online from 17 to 19 August 2022.

The E/CAR/NTG/11 Meeting will analyse the performance and operation of the E/CAR Aeronautical Fixed Service (AFS) Network. The E/CAR/RD/9 Meeting will discuss surveillance data for Air Traffic Services (ATS) in the E/CAR States and it will identify the new E/CAR Surveillance States Implementation in some E/CAR States.

The meeting will be a good opportunity that E/CAR States will integrate to the work of the development of the Electronic Air Navigation Plan (e-ANP) Volume III and integrate regional objectives into their own aviation action plan.

The objective of this meeting will be to update the work plan of the E/CAR/NTG and E/CAR/RD groups according to the current needs of the E/CAR States and its operation with the other NAM/CAR States and to evaluate the possibility to integrate some of their backup communication needs in the new Caribbean Air Navigation Services Network (CANSNET).

The E/CAR/CATG/6 Meeting will follow up on the implementation of E/CAR air navigation matters to contribute to the accomplishment of the CAR Air Navigation Services (ANS) Regional plan, updating information about the electronic air navigation plan, Volume I and II, evaluation of the Basic Building Blocks (BBB) and review the E/CAR Region progress based on the results of the NAM/CAR Air Navigation Implementation Working Group (NACC/WG) Meeting. As a result of these meetings, the E/CAR States will update the E/CAR/CATG action plan according to the NACC/WG objectives.

For this Meeting, the E/CAR Air Navigation Service Providers (ANSP) and Civil Aviation Authorities (CAA) members are expected to attend, specifically personnel from different air navigation areas such as Aeronautical Information Management (AIM), Aerodromes and Ground Aids (AGA), Air Traffic Management (ATM), Communications, Navigation and Surveillance (CNS) and Meteorology (MET). All members of the E/CAR/NTG, E/CAR/RD, and E/CAR/CATG are expected to participate.

The provisional agendas and provisional schedules for the E/CAR/NTG/11 and E/CAR/RD/9 meetings are presented in **Appendices A and B** to this letter. For the E/CAR/CATG/6 meeting, they are presented in **Appendices C and D**. The States/Territories that wish to propose additional agenda items must send them to this Regional Office by 20 July 2022, clearly stating the corresponding meeting to which the proposal refers.

Any documentation that your Administration/Organization may wish to present should be forwarded to this office via e-mail by 25 August 2021 in Microsoft Word format using the attached templates (**Appendices E to L**). Working papers should be brief, action-oriented, and focused with a fourpage limit excluding any appendices. For your participation and the participation of your delegates in the meetings, please register by **10 August 2022** using the following links, depending on the meeting to attend:
