1. Introduction

- 1.1 Following up on the WP MEVA/TMG/36 WP/08, presented by the Secretariat during the MEVA/TMG/36 Meeting in June 2021, the next steps to development CANSNET Project were discussed.
- 1.2 Within the MEVA/TMG/36 meeting, the conclusion MEVA/TMG/36/03 "APPROVAL OF THE EXTENSION OF THE CONTRACT WITH THE CURRENT SERVICE PROVIDER MEVA III UNTIL MARCH 2025" was also agreed.
- 1.3 During the meetings held by the Ad-Hoc group, part of MEVA/TMG and responsible for managing the development of the project, agreements were discussed and reached for the benefit of the Group and for the network to have a positive impact on the region.

2. Discussion

2.1 As a first point, the ICAO NACC Office wishes to congratulate the members of the CANSNET Ad-hoc Group for the work done, we know that this work demands additional work to their responsibilities within their organizations, therefore the NACC Office recognizes this work and has expressed this with each of its Organizations. As well as the staff that has supported the work developed to date.

- 2.2 As reported during the MEVA/TMG/36 meeting in 2021, the RFI process of the CANSNET project was concluded, obtaining only information on the available technologies, but no information on the actual costs of the project development.
- 2.3 In this sense, a series of meetings were held with the ICAO Technical Cooperation Bureau (TCB) to define the mechanisms by which the project management process would be carried out by that unit.
- 2.4 The AD-hoc group also drafted what will be the bidding document for the new phase of the network, in its general body, without defining the customization of requirements for each State. This definition should be obtained through an individual analysis with each of the States, including their local, regional and global needs.
- 2.5 In that sense it is necessary for each State to work more closely with MEVA Ad-hoc staff as well as with their internal units to define these requirements. The activities have been developed with respect to the June 2022 deadline.

- 2.6 To date it is important to establish the basic administrative requirements for TCB to manage the project on behalf of the MEVA States and individual State work is required to include the technical/operational requirements of each State.
- 2.7 Finally, State approval of the final requirements is required and once the cost of the project is estimated, the investment budget can be defined in each MEVA Member State.
