Dear Sir/Madam,

During the Second State Safety Programme (SSP) Meeting for the NAM/CAR Regions (NAM/CAR/SSP/2) held on-line on 4 November 2021, a revised SSP Strategy for the NAM/CAR Regions was developed. It was presented to the Tenth North American, Central American and Caribbean Directors of Civil Aviation Meeting (NACC/DCA/10). Following this update, the SSP implementation for the CAR Region will be supported with Regional Aviation Safety Group—Pan America (RASG-PA) funds in the next years and accompanied by the Systemic Assistance Programme (SAP) "Champion States". The designation of the new SSP Working Group (WG) Rapporteurs for the English-speaking and Spanish-speaking teams is on-going. I thanks their Administrations for this support to the States and the region.

The effective and sustainable implementation of the SSP among States is a main priority, in line with the compliance with the ICAO Global Aviation Safety Plan (GASP) goals and assuring the agreed levels of safety throughout the region. The SSP WG seeks to support States to increase their effective SSP implementation as part of the core elements of safety risk management. In this regard, I wish to invite your Administration and, in particular, your State's SSP Points of Contact (PoCs), to participate in the Third State Safety Programme (SSP) Meeting for the NAM/CAR Regions (NAM/CAR/SSP/3) to be convened at the ICAO NACC Regional Office, Mexico City, Mexico on 17 and 18 November 2022.

In this meeting, and following the SSP/WG Terms of Reference (ToRs), the review of the status of the SSP implementation in the NAM/CAR Regions will continue, among the main discussion items. The meeting aims at defining the upcoming activities of assistance and support to States for SSP implementation (SSP Work Programme).
