CAR/SAM Regional Planning and Implementation Group	The CAR/SAM Regional Planning and Execution Group (GREPECAS) is responsible for the development and maintenance of air navigation plans and provides the planning and implementation of air navigation systems within specific areas, in accordance with planning frameworks agreed at global and regional level. During the Twentieth Meeting of the CAR/SAM Regional Planning and Implementation Group (GREPECAS/20), held in Salvador, Brazil, from 16 to 18 November 2022, Conclusion GREPECAS/20-4 was approved, which formed an Ad hoc Group with the responsibility of developing a GREPECAS project aimed at the regional management of aeronautical frequencies for the CAR/SAM Regions.

CAR/SAM Regions current situation	States of the CAR/SAM Regions do not manage the frequency spectrum in an effective and standardized manner, which contributes to a lack of regional coordination and an increase in potential interference in the provision of air navigation services, compromising safety.
Nature of the event	Initial event for the structuring of a GREPECAS project, for the elaboration of the terms of reference, work plan, expected deliverables and other required documents.
Participants Profile	Experts with experience in handling the frequency spectrum and knowledge of the service licensing processes, frequency assignment and the activities carried out by the Frequency Spectrum Management Panel (FSMP) and the Inter-American Telecommunications Commission (CITEL), with a view to the International Telecommunication Union (ITU) World Radiocommunication Conference 2023 (WRC-23).
