



Aerodrome emergency planning is the process of preparing an aerodrome to cope with an emergency occurring at the aerodrome or in its vicinity.



The object of airport emergency planning is to minimize the effects of an emergency, particularly in respect of saving lives and maintaining aircraft operations



The aerodrome emergency plan sets forth the procedures for coordinating the response of different aerodrome agencies (or services) and of those agencies in the surrounding community that could be of assistance in responding to the emergency.



The plan shall contain procedures for **periodic testing** of the adequacy of the plan and for reviewing the results in order to improve its effectiveness.



- a) **types** of emergencies planned for;
- b) agencies involved in the plan;
- c) responsibility and role of each agency, the emergency operations centre and the command post, for each type of emergency;
- d) information on names and telephone numbers of offices or people to be contacted in the case of a particular emergency; and
- e) a grid map of the aerodrome and its immediate vicinity.



Volume I - Aerodromes

The **plan shall be tested** by conducting:

- a) a **full-scale aerodrome emergency exercise** at intervals not exceeding **two years and partial emergency exercises** in the intervening **year** to ensure that any deficiencies found during the full-scale aerodrome emergency exercise have been corrected; **OR**
- b) a **series of modular tests commencing** in the first year and concluding in a **full-scale aerodrome emergency** exercise at intervals not exceeding **three years**;

and reviewed thereafter, or after an actual emergency, so as to correct any deficiency found during such exercises or actual emergency.

To be operationally sound, a comprehensive **airport emergency plan** must give consideration to:


- a) preplanning **BEFORE** an emergency;














Amendments in ICAO Airport Service Manual Doc. 9137 Part 7

- What are the types of emergencies defined in your aerodrome emergency plans and procedures?
- 4) Does the airport have the materials and equipment available at the airport for the types of emergencies set out in the airport emergency plan?
- 5) Does the airport have a fixed emergency operations center available to use during an emergency?
- 6) Does the airport have a mobile command post available at the airport to use during an emergency?
- 7) The first step in a viable emergency plan is to have the cooperation and participation of all involved airport/community authorities. In this case, which agencies are considered in your airport emergency plan? (predefined list with possibility to include other agencies)

- 8) Is there designation of predefined color clothing with reflective lettering, helmets and vests or for use by command personnel for easy identification in an emergency?
- Does the airport have communications systems linking the command post and emergency operations center with each other and with participating agencies (ex., firefighters, security, medical assistance, civil defense, and other government agencies)?
- 10) How often does the airport conduct a full-scale aerodrome emergency drill to test the airport emergency plan?
- 11) How often does the airport conduct a partial emergency exercises to test the airport emergency plan?
- 12) How many modular emergency tests does the airport conduct in a year to test the airport emergency plan?
- 13) The aircraft emergency plan is revised after testing or after an actual emergency to correct any deficiencies found during such exercises or emergency?
- 14) What types of real emergencies have occurred at the airport in the last five years?
