The RASG-PA, through its members, develops and take actions and initiatives to support the fulfillment and implementation of the ICAO Global Aviation Safety Plan (GASP), through the establishment and operation of an aviation safety system based in the Pan American region performance. RASG-PA's activities adopt a collaborative methodology between States, International Organizations, and the industry, through the collection and exchange of data, for an adequate hazards identification, and risks management for the determination of mitigation actions. The ESC is responsible of: • developing and approving the RASG-PA work plan including objectives, priorities, indicators and setting of measurable targets to address safety-related issues in the NAM/CAR and SAM Regions; • approving projects presented to the ESC; • coordinating the projects approved by the ESC; • approving the Safety performance indicators (SPIs), Safety Enhancement Initiatives (SEIs), Detailed implementation plans (DIPs) and Safety Performance Targets (SPTs); • overseeing the activities of the Pan America Regional Aviation Safety Team (PA-RAST), Safety monitoring and report team (SMRT), working groups and committees; • reviewing and approve the RASG-PA Annual Safety Report; • approving the RASG-PA budget; and • managing the budget.
