I wish to invite your Administration/Organization to participate in the Eighth North American, Central American and Caribbean Working Group Meeting (NACC/WG/8), to be convened at the ICAO NACC Regional Office, Mexico City, Mexico, from 29 August to 1 September 2023.

The objective of the meeting is to analyse the results of the 2022-2023 work plan, to follow-up on the work plan developed in March 2023 by the rapporteurs of the different Task Forces (TF) of the NACC/WG, as well as to update the activities of the different areas of air navigation.

At the end of the meeting, the expected results are:

- 1. Establish the status of implementation of Air Navigation in the CAR Region according to the work carried out by each NACC/WG TF in the evaluation of the Basic Building Blocks (BBB) and the elements of Aviation System Block Upgrade (ASBU).
- 2. Establish the regional Key Performance Indicators (KPIs) according to the work presented by the Airspace Optimization Task Force (AO/TF), the Air Traffic Flow Management Implementation Task Force (ATFM/TF) and the Surveillance Task Force (SURV/TF).
- 3. Respond to the decisions and conclusions of the Twentieth Meeting of the CAR/SAM Regional Planning and Implementation Group (GREPECAS/20) to provide the results at the GREPECAS/21 Meeting.

Each TF member of the NACC/WG must present the results of their work management according to the work programme of their Groups, the objectives set in common, and the results obtained to date. This information will be key to continue with the regional implementation of Air Navigation Services (ANS), the establishment of the capacity implemented in the region and continue with the development of the Electronic Air Navigation Plan (e-ANP) Volume III. It will also continue to monitor regional priorities and the implementation of the established goals for the region in the different areas of air navigation: Air Traffic Management (ATM), Aeronautical Information Management (AIM), Communication, Navigation and Surveillance (CNS), and Search and Rescue (SAR), the follow-up to the conclusions of GREPECAS and North American, Central American and Caribbean Directors of Civil Aviation Meetings, related to ANS.

The members of the different TFs of the NACC/WG are expected to attend the meeting: ATFM/TF, AO/TF, SURV/TF, Air Traffic Services Inter-facility Data Communication Task Force (AIDC/TF), Search and Rescue Implementation Task Force (SAR/TF), Aeronautical Frequencies (FRE), Communications Management (COMM), Aeronautical Meteorology (MET), Aerodromes and Ground Aids (AGA), as well as the participation of the rapporteurs of the Groups of the Eastern Caribbean States. The participation of experts in all areas of air navigation, technical and operational personnel responsible for the implementation of ANS, ANS Project Managers from States, as well as International Organizations and Industry is also expected. The working languages of the meeting will be **English** and **Spanish**, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

The Provisional Agenda and Schedule of the event are at **Appendices A and B** respectively. States wishing to submit proposals for the addition of items should do so by **21 July 2023**. Information papers will only be issued in the language submitted. Papers received from international organizations will not be translated and will be issued only in the language submitted. The deadline to receive papers is 15 August 2023. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages (i.e., English and Spanish).
