During this meeting, an update of the work carried out so far by the NCMC working groups will be provided and the tasks that the working group has set for the immediate future, since as a follow-up to the agreements of the Fifth Regional Meeting of National Coordinators of Continuous Supervision (NCMC/5), the ICAO NACC Regional Office has initiated a series of activities with the working groups of the NCMCs, including the issuance of a survey of needs for the fulfilment of the functions of the NCMC related to the OLF, which provided valuable information to start the development of lines of work that help solve these needs.

Likewise, Systemic Assistance Programme (SAP) have been updated, this update will be explained during this meeting. In addition to the above, the progress achieved in the Safety Oversight System (SOS) Project will be presented, the model used by Mexico for the establishment of risk-based surveillance, a review of the effectiveness of the guidelines developed in the USOAP Air Navigation Services (ANS) will also be presented and some topics of the surveys carried out will be discussed for a better understanding of the information provided and the application of improvements.

NCMCs of States and Territories of the ICAO NAM/CAR Regions and representatives of Regional Safety Oversight Organizations (RSOOs) are expected to attend. The working languages of the meeting will be English and Spanish, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

These results mainly point to the lack of personnel in the authorities, lack of training in general and lack of understanding and depth of the ICAO Protocol Questions (PQs) and the Online Framework (OLF).

The effectiveness and uses of the guides developed such as the Air Navigation Services (ANS) inspector manual guide will be analysed, the progress made in solving the issues identified in the survey and solution proposals/work to be carried out to address the most deficient or less compliant areas will be discussed.

# Agenda Item 3: Presentation of the update of procedures of the Systemic Assistance Programme (SAP) of the NACC Regional Office

Under this agenda item, the new procedures of the NACC Systemic Assistance Programme (SAP) will be shown, which has been updated to streamline communication between the technical areas of the authorities and the Regional Office, systematically improving the support provided to the States, as part of the continuous improvement of the assistance provided by the NACC Regional Office.

The meeting will review the status of compliance shown through the RASG-PA and NACC Dashboards, as well as the latest annual report of the Regional Aviation Safety Group-Pan America (RASG-PA) related to Universal Safety Oversight Audit Programme (USOAP) topics.

#### Agenda Item 4: Progress of the State Safety Oversight System (SOS) Improvement Project
