












#### NACC Systemic Assistance Programme (SAP) New Overview

#### **Continuous Improvement Process of the SAP Programme:**

Simplification and focus on technical assistance from ICAO NACC Regional Officials to States

Work and approach directly linked to the USOAP OLF and USAP Corrective Action Plans (CAP)/Self-Assessment Replacement of SAP Action Plan by USOAP and USAP Executive Summaries: References for Work and Follow-up

Updating and mandatory work with the data and information in the USOAP OLF Portal and CAP data / USAP Self-assessment

Sampling responses to USOAP /USAP Protocol Questions 100% complete



Standardized follow-up and monitoring reports of technical and high-level meetings

Public monitoring through the NACC ICAO Dashboard







#### 03 Roles and responsibilities to implement the SAP





#### NACC States and Territory

- ★ Perform a **100% self-assessment** for USOAP on ICAO OLF online platforms.
- ★ Complete and maintain updated CAP for USOAP on ICAO OLF online platforms for States that have had an ICAO audit within the past 5 years.
- ★ Complete 100% of the USAP Action Plan.

🐺 ICAO

- ★ Assign State Focal Points to each of the 8 Areas of the USOAP and one to the USAP to receive assistance from the Regional Officers (RO) of the ICAO NACC Regional Office.
- ★ Assign State representative (can be the NCMC) to follow up on SAP projects and activities with the Regional Office NACC ICAO in charge of the States.
- Participates in the High-Level Teleconference with the Regional Director or Deputy Regional Director to monitor the assistance and progress of the State.

## ICAO NACC Office Regional Director/ Regional Deputy Director

- ★ Make contact with the States to establish the Political Commitment to comply with the Systemic Assistance Programme of the NACC Office;
- ★ Keep the master version of personalized presentation for the State about Systemic Assistance Programme;
- ★ Sign the "Declaration of Intent" (Appendix A) with the States to consolidate political commitment to the SAP.



Participates in the High Level Semiannual Teleconferences with the States to monitor the assistance and progress of the State (Appendix E).

#### **ICAO NACC Regional Officer**

ICAO

- ★ The assignments of State and specific areas are given in the SAP Assignment Table (Appendix G).
- ★ Review and analyze the State's progress in updating the CAP and Self-Assessment on OLF in USOAP in their respective areas, and for AVSEC/FAL by documentation in USAP.
- ★ Provide technical assistance on compliance with the Protocol Questions (PQs) of the USOAP in their respective areas, or (for AVSEC/FAL) USAP. This is done through Virtual Teleconferences (Technical SAP Teleconference) or Multidisciplinary Assistance Mission (TEAM -when necessary), with the periodicity established in Annex F.
- ★ For Technical SAP Teleconferences, prepares a SAP USOAP Technical Progress Report (Appendix C) or SAP USAP Technical Progress Report (Appendix D) for the State according to analyzes and assistance carried out with the State Focal Point, in their respective areas.
- ★ For TEAM mission, **prepares a TEAM Mission report** for the State as established in NACC SOP.

#### **ICAO NACC Regional Officer**

- Send the SAP Technical Report Progress in your area of responsibility to the NACC ICAO
  Regional Officer in charge of the States with the established minimum frequency (Appendix G).
- ★ Manage SAP projects with specific scope of your area of responsibility (Appendix H)
- ★ In case of the Regional Director or Regional Director Deputy is not present, make the personalized presentation for the State about Systemic Assistance Programme and about USOAP-CMA and/or USAP (depending on whether it involves safety and/or security issues).



#### ICAO NACC Regional Officer

- ★ Establishes agreements or responds to the request of the State, for the execution of the Technical Assistance Mission, when involving only one assistance area.
- ★ Coordinates and conducts the Teleconference for feedback on the Mission Report and Priority Actions, when involving only one assistance area.
- ★ Provide support to the NCMC Coordinator of the NCMC Groups as requested for the resolution of regional issues (reported by the NCMCs Groups)

### ICAO NACC Regional Office in charge of the States and Territories

- ★ Prepare the SAP High Level Report Teleconference (Appendix E) of your State (Appendix G) for the NACC ICAO RD or DRD.
- ★ Coordinates and carries out the Teleconference with the State representative (when necessary) for the analysis and/or modifications of the State's information.
- ★ Establishes agreements or responds to the State as applicable, for the execution of the Multidisciplinary Assistance Mission, when involving more than one assistance area.

ICAO


- ★ Coordinates and conducts a feedback Teleconference to monitor the Mission Report results and Priority Actions, when involving more than one assistance area.
- ★ Manage SAP projects with a scope involving more than one area and specific to the assigned
  State of responsibility (Appendix G).

#### ICAO NACC Regional Office in charge of the States and Territories

★ Provide relevant information to the NCMC Coordinator of the NCMC Groups, related to specific technical problems needing the support of the NCMCs.
