- What are Runway Incursions (RIs)?
 - ICAO Definition: "Any occurrence at an aerodrome involving the incorrect presence of an aircraft vehicle or person on the protected area of a surface designated for the landing and take off of aircraft"
 - RIM focuses on PDs and V/PDs
- How can ARP help?
 - Problematic Taxiway Geometry (PTG) Study, DOT/FAA/TC-18/2
 - Link on the ARP RIM page: https://www.faa.gov/airports/special_programs/rim/
- What are PTGs?
 - Geo-located R/W-T/W intersections
 - GeoCodes * 19 Taxiway Elements * AC 150/5300-13A and -B







Runway Incursion Mitigation (RIM) Program

RIM, est. June 2015, determines which runway/taxiway intersections

have increased occurrences of RIs.

- The RIM program uses:
 - Runway Incursion data
 - GIS geo-referencing, and
 - Risk-based Decision Making
- Locations Determined by:
 - 3 or more RIs in a Calendar Year
 - Average of 1+ RIs/year (last 10 years)
 - Validation of locations, RIs, & geometry
- Generates public RIM Inventory





Runway Incursions V/PDs & PDs by Geocode








6,648 Geo-located points (PTG locations)

More than 45% associated with at least 1 RI












16,000+ Runway Incursions Events Geo-referenced

- Data mining effort collected 12+ years (FY2007 CY2022) of RI data from towered airports.
- V/PDs and PDs











RIM FAA Roles/Responsibilities

ALL ARP – Mitigation Strategies

- Geometry Improvements
- Signage, Marking, Lighting
- Procedures
- Technology (ATAP, RIPSA?, etc.)
- Pilot Education may help







RIM FAA Roles/Responsibilities

- Data Integration, Analysis, Evaluation
- Internal & External Communications
- Ensure Business Goals are met
- National Coordination
 - ARP
 - FAA LOBs
- SMEs for Mitigation Solutions
- RDM Tool Direction, Management







RIM FAA Roles/Responsibilities

Regional/ADO Project/Program Managers

- Annual (May July) potential RIM location validations
- Update RIM info into RDM Tool*
- Coordinate with Airport Sponsors
 - Assist in mitigation development
 - ACIPs, long term planning
- Coordinate with FAA LOBs
 - Procedures
 - Facilitate mitigation implementation
- Flag RIM projects in SOAR
- Look for other opportunities to mitigate

*Quarterly, or As Necessary








Albuquerque International

- Wrong Runway Events






FY 2018 Mitigated

- 1 Runway Incursion since, but no wrong runway events






- Terre Haute International

- •0 Incursions post-mitigation









Waco Regional, ACT-HS1

- 5 RIs from 2009 - 2012






- Green island eliminates direct access

FY 2019 Mitigated


- Pavement marking eliminated direct access

RIM - Current Status

RIM Quick-Hit Statistics:


- 522 towered airports
- 123 RIM locations in current inventory
 - https://www.faa.gov/airports/engineering/incursions excursions/rim
- 79 airports w/ at least 1 RIM location
- 100+ RIM locations associated w/ new project
- Mitigations reduce RIs an <u>average of 78%</u>
- 93 RIM Locations *mitigated*
