This questionnaire was designed to identify the level of safety knowledge of drivers who access the maneuvering area of the International Airport. The answers will be treated statistically, without identification of the driver, with the sole purpose of evaluating the drivers' training system.

- 1. Observe the following dialogue between a driver and Control Tower and mark the lines that do not adjust to the phraseology.
 - a) Driver: "Good morning, Tower".
 - b) Driver: "Tower, OSCAR UNIFORM".
 - c) Tower: "OSCAR UNIFORM, Tower".
 - d) <u>Driver</u>: "Tower, OSCAR UNIFORM in taxiway alpha, I request permission to cross runway 14".
 - e) Tower: "OSCAR UNIFORM, Runway 14 crossing is cleared".
 - f) Driver: "Ok!"
 - g) Driver: "Tower, thank you very much and have a great day!"
- 2. Do you wish to enter the runway. Ask permission to Control Tower to access the runway. The controller grants authorization. What do you do?
 - a) Warns the controller that is listening;

- 3. You are driving a vehicle with a OSCAR-1 sign and request permission to Control Tower to cross runway 15. The controller responds "please wait". - 14. You are driving in a taxiway and see a sign with the signage below. What does it mean?




- a) Informs that you are in taxiway "A";
