Dear Sir/Madam,

Further to previous communications Ref.: LS 8/25-SA516, dated 18 October 2023 (SAM), and E.OSG-NACC109553, dated 23 October 2023 (NACC), we wish to invite your Administration/Organization to participate in the Twelfth Meeting of the ICAO/LACAC NAM/CAR/SAM Aviation Security and Facilitation Regional Group (AVSEC/FAL/RG/12), to be held in Lima, Peru, from 8 to 10 May 2024, under the auspices of the General Directorate of Civil Aviation (DGAC) of Peru, preceded by the Air Cargo Workshop from 6 to 7 May 2024, which will cover air cargo security and facilitation, highlighting digitalization.

This meeting of the Regional Group will seek to specify the work and initiatives of the States to promote facilitation and security of civil aviation. The challenges in the implementation of activities on these topics will be discussed, actions will be analyzed and adopted to implement good practices on air cargo, and cooperation on AVSEC and FAL will be sought. Likewise, the States will be updated on the actions proposed by the AVSEC Panel (AVSECP), FAL Panel (FALP) and Cybersecurity Panel (CYSECP), as well as on the Collaborative Arrangement for the Prevention and Management of Public Health Events in Civil Aviation (CAPSCA) programme.

AVSEC and FAL personnel from States and Territories of the ICAO NAM/CAR and SAM Regions and representatives of international organizations are invited to attend. Participants are expected to provide an update on the implementation of their AVSEC and FAL projects, to share actions adopted for the promotion to the Year of Facilitation - FAL2024, the challenges of the implementation of cybersecurity, and other topics they consider relevant to the meeting. The working languages will be English and Spanish, and simultaneous interpretation services will be provided.
