Sir/Madam:

I have the honour to inform you that ICAO will be carrying out a Regional NAM/CAR/SAM Preparatory Meeting (RNCSPM) for the ITU World Radiocommunications Conference (2012) (WRC-2012) in the ICAO NACC Regional Office from 21 to 22 April 2010. This event will be followed by the 22nd meeting of the Aeronautical Communications Panel - Working Group F – Spectrum Management (ACP-WG/F) that will be held from 23 to 30 April 2010.

These events are intended to assist States in their understanding and practice of aeronautical radio frequency spectrum management, and in their activities to support the ICAO position for the WRC 2012.

Specifically, the RNCSPM for WRC-2012 will include a frequency spectrum management workshop and discussion of the preparatory activities for WRC-2012. The main purpose of the event is to provide States, Territories and International Organizations within the NAM/CAR/SAM Regions with an overview on the radio frequency spectrum management matters and a forum for the preparation of the ITU WRC-12, in order to facilitate a more effective participation at the national and regional level forums within the NAM/CAR/SAM Region in support of the ICAO position. **Appendix A** to this letter contains the Draft Programme for the RNCSPM.

Following the RNCSPM, the ACP-WG/F will address at a global level, with the participation of international ACP experts, the various radio frequency spectrum related issues contemplated in its work programme, with special regard to the preparation of ITU WRC-12. Participants to the RNCSPM are encouraged to attend the ACP-WGF meeting for additional in-depth exposure to the issues associated with the preparation for WRC-2012.

The intended audience for these events are the States' designated WRC-2012 focal points, as well as CNS personnel responsible for aeronautical radio frequency spectrum issues associated to the planning and implementation of CNS services.

In this regard, you are cordially invited to participate and inform this Regional Office of your attendance by **26 March 2010**, by completing the registration form included as **Appendix B** to this letter. The RNCSPM will be carried out with simultaneous interpretation in English/Spanish. However, the simultaneous interpretation services will be confirmed considering the participants' registration. The ACP-WG/F meeting will be only in English. Registration may be to one or both of the events.

Regarding the draft programme, your Administration can also support the event by providing a presentation on the topics contained in the programme or any other that your Administration consider convenient to present in relation to the RNCSPM.

In this regard, I would appreciate that you confirm your intention to support the RNCSPM with a presentation no later than **12 March 2010**, by informing the name of the speaker, title of the presentation, duration and its summary. All presentations should be submitted to this Regional Office by **12 April 2010**.
