I have the honour to inform you that the Meeting of Air Navigation and Flight Safety Directors of the SAM Region has been scheduled to take place in Lima, Peru, from 21 to 22 October 2013, in preparation of the Thirteenth Meeting of Civil Aviation Authorities of the SAM Region (RAAC/13) to be held in Bogota, Colombia, from 4 to 6 December 2013.

The objective of this Meeting is to obtain consensus on the goals of the SAM Region for the next years on a number of indicators proposed by the ICAO Secretariat in the areas of Efficiency and Safety, within the framework of the global plans on air navigation (GANP) and safety (GASP). These goals are framed within the "only what can be managed, can be measured" concept.

The determining of goals, together with the highest commitment to achieve them, are two key elements for the establishment of an ICAO website entitled Online Performance Dashboard, to be published in March 2014, and which will be part of the information to be contained in the ICAO global air navigation and safety plans, scheduled for publication in April 2014.

During the meeting, the directors of air navigation and flight safety of the SAM Region will be able to analyze the metrics of several indicators, both in the air navigation as in the safety areas, with the purpose of defining metrics able to be complied with, but at the same time of great ambition.

The Meeting is aimed only for the directors of air navigation and flight safety of the SAM Region.

In this regard, I would like to invite your administration to participate in this important event, and propose the name of your candidates no later than 27 September 2013.

The agenda of the meeting will be sent as soon as possible. The event information paper, which contains general information to assist the participants, is provided in **Appendix A**, and the registration form to be filled by each participant, in **Appendix B**.

The working language of the workshop will be English and Spanish. The daily subsistence travel allowance in addition to other costs for participants are the responsibility of the nominating States.
