I have the honour to invite your administration to participate in the Third Seminar/Workshop on the Implementation of Airports – Collaborative Decision Making (A-CDM), which is an activity co-financed by RLA/06/901 Regional Project - Assistance in the implementation of a ATM regional system according to the ATM operational concept and the corresponding technological support for communications, navigation, and surveillance (CNS), and will be held at ICAO South American (SAM) Regional Office, from 25 to 27 September 2017.

The purpose of this seminar/workshop is to support States and other operational partners providing updated information on the A-CDM concept, besides analyzing, through the preparation of workshops and group discussions, the steps to follow in order to identify, plan and assist in A-CDM implementation in the aerodromes of high density in the SAM Region, in order to facilitate ASBU BO-ACDM implementation.

In view of the above, I will appreciate your considering proposing Aerodromes Operations and Ground Aids (AGA/AOP) experts, aerodrome Air Traffic Controllers and Air Traffic Flow Management (ATFM) specialists to participate in the event, besides extending this invitation to airport and airlines operators and air navigation services providers.

- a) fellowships from a national ICAO Technical Cooperation Project approved for your State; or
- b) fellowships sponsored by Regional Project RLA/06/901 for member States of RLA/06/901 that do not count with the above alternative, having the interested administration to provide the air tickets to and from the host country; or
- c) own resources of your administration, in the lack of any of the previous alternatives.
