1. Background

1.1 The First Meeting of the Programmes and Projects Review Committee (PPRC/1) was held at the ICAO North American, Central American and Caribbean (NACC) Regional Office, in Mexico City, Mexico, from 25 to 27 April 2012. Thirty participants from 10 PRCC member States, 1 other GREPECAS member State of the CAR/SAM Regions, and Observers from 2 International Organizations attended the PPRC/1 meeting.

1.2 The **Appendix** to this working paper contains the conclusions and decisions adopted at the first meeting of the PPRC/1, the action taken by CAR/SAM States/Territories/International Organizations and/or the ICAO Secretariat. After analysing the action taken, the Secretariat concluded that all the conclusions of the PPRC/1 meeting had been finalized or were rendered invalid by time, developments or by actions to be taken at this meeting.
