EXECUTIVE SUMMARY

This Working Paper presents the Matters Arising or Status of implementation of the Decisions and Recommendations made by the 6th Steering Committee Meeting held in Montreal Canada on 8 December 2017 and an overview or assessment of implementation of the AFI SECFAL Plan performance with regard to outstanding short term and ongoing Midterm (2018-2020) activities. The Steering Committee is requested to note the information contained in this paper and in particular the implementation of the Recommendations and decisions as highlighted in Attachment A to this Working Paper.

1. BACKGROUND INFORMATION

1.1 The Sixth Meeting of the Comprehensive Regional Implementation Plan for Aviation Security and Facilitation in Africa (AFI SECFAL Plan) Steering Committee (SC) was held on 8th December 2017 in Montreal, Canada. The SC made various Decisions and Recommendations that required action by the Secretariat and other Stakeholders.

1.2 The Meeting further requested the Plan Secretariat to carry out an assessment and overview of the Plans performance with regard to completed short-term activities and strategically undertake medium-term activities.

2. DISCUSSION

2.1 During the period of implementation (Dec 2017- June 2018), some of SC decisions and recommendations have been implemented in full while some are ongoing, as detailed under **Attachment A**. The SC will be provided with a complete update on the implementation status at the next SC meeting.

2.2 With regard to the alignment of the AFI SEC Plan, Windhoek Declaration and Targets, GAsEP and AFI-Mid Targets, the exercise was performed by the secretariat and a specific Working Paper has been developed as detailed in **WP/03**. Similarly, the analysis of USAP-CMA results to determine AFI common deficiencies and needs was done and the details are in **W/P 04**. Furthermore, after the approval of the Resource mobilization strategy, and establishment of the AFI SECFAL Plan Fund, it was also found prudent to provide the Status of the AFI SECFAL Plan Financial Status detailed in **WP/05**.

2.3 Most of the activities planned for the Short Term period (2015-2017) have been completed in line with the timelines given in the Plan Work Programme, and the Plan secretariat has started implementing the activities planned under Mid-Term Phase (2018-2020).

3. CONCLUSION

3.1 Based on the status of implementation of decisions and recommendations of the 6th Steering Committee, the implementation of the work programme for 2018, completion of most of the the short term activities, (2015-2017), and the GAsEP and other existing frameworks, it is evident that the AFI SECFAL Plan Targets will need to be revised during the Plans mid-term review in 2019.

3.2 The AFI SECFAL Plan secretariat has continued to implement the Plan activities utilising limited resources and expertise provided under ICAO regular budget, and in kind or financial voluntary contributions from States/donors partners. Based on the deficiency needs analysis conducted, it is inevitable that more resources are needed to guarantee continuity, effective implementation and achievement of the Plan objectives.

4. ACTION BY THE STEERING COMMITTEE

4.1 The Steering Committee is invited to:

- a) Note the information contained in this paper and in particular the implementation of the Recommendations and decisions as highlighted in **Attachment A** to this Working Paper.
- b) Provide further instruction, guidance and recommendations for the continued implementation of the Plan.
- c) Continue the advocacy to establish a sustainable funding mechanism especially through inclusion of the Plan in the next triennium budget (2020-2022).
