1. BRIEF REVIEW OF WORK DONE ON THURSDAY, 27 NOVEMBER 2008

1.1 The Efficiency Committee held its third meeting and completed its discussions on WPs 14, 15, 19, 25, 30, and 70. The Efficiency Committee completed its discussions on Agenda Item 6 – Development of a set of comprehensive work programmes in the air navigation field, aimed at improving efficiency of the air navigation system.

1.2 The Safety Committee held its third meeting and completed its discussions on WPs 32, 27, 31, 9 and 75. The Safety Committee completed its discussions on Agenda Item 5 – Development of a set of comprehensive work programmes in the safety field. The meeting agreed to preliminary target dates to meet the objectives of each of the Global Aviation Safety Initiatives for the AFI Region.

1.3 The Committee, in reviewing the activities and the work programme of ACIP, endorsed the short- and medium-term actions designed to enable States to acquire the capability for an effective and sustainable safety oversight system, including the plan for transferring the activities of ACIP into the regional office activities to ensure its continuity beyond 2011.

2. PROGRAMME OF WORK FOR FRIDAY, 28 NOVEMBER 2008

2.1 The Efficiency Committee will convene in Plenary to review WP/84 containing the draft report on Agenda Item 6.

2.2 The Safety Committee will convene in Plenary to review WPs 82 and 83 containing the draft reports on Agenda Items 4 and 5, respectively.
