#### 1. **INTRODUCTION**

- 1.1 In order to assist States to meet their commitments under ICAO Assembly resolution A37-11 for Performance-Based Navigation (PBN), the AFPP assistance to States and Organizations consists in conducting trainings, providing flight procedure design and granting access to IFP-related automation solutions.
- 1.2 In this regard, many States or Organizations agreed with the Programme for implementation of flight procedures (visual and instrument). However, due to the Covid-19 hit and consecutive restrictions in 2020 and 2021, the completion of some of these projects is delayed. The previous steering committee meeting (SC/7) approved to reschedule their completion. This paper provides the implementation status of these projects. It should be noted that some of them were transferred to phase III which just started on 1<sup>st</sup> August.

## 2. **DISCUSSION**

- 2.1 The last steering committee meeting (SC/7) noted that six (06) flight procedure design projects were not yet completed and took decision SC/7-Dec05 extending Phase II of the Programme until 31 July 2022 in order to allow the completion of a maximum number.
- As of 23 August 2022, four (04) out of the six projects are completed while two (02) are still outstanding due to financial, technical or security reasons. The table below gives details on the relevant projects as well as the reasons why they are still pending.
