EXECUTIVE SUMMARY

This working paper presents the implementation status of the decisions taken during the 8th Meeting of the AFPP Steering Committee, which was held in Dar es Salam, United Republic of Tanzania, from 23 to 24 August 2022.

Report of the SC8/22-Meeting

1. **INTRODUCTION**

- 1.1 The 8th meeting of the African Flight Procedure Programme (AFPP) Steering Committee (SC/8), which was held in Dar es Salam, United Republic of Tanzania, from 23 to 24 August 2022, reviewed the Project achievements with regard to its set objectives and approved the new governance document as well as the 2022-2023 work programme and the corresponding budget.
- 1.2 This paper reports on the implementation status of the decisions taken during this meeting.

2. **DISCUSSION**

- 2.1 The Eight Steering Committee endorsed ten decisions and instructed ICAO to coordinate with the Namibia Civil Aviation Authority for the hosting of the 9th Steering Committee Meeting. However, the Secretariat was reminded that in line with ICAO policy, the Steering Committee meetings should take place on an alternating basis in the ESAF and WACAF regions. As the last meeting was held in the ESAF region, Togo accepted to host the present meeting. We renew our deep thanks to Togo for having accepted to host the meeting with short notice.
- 2.2 As shown in Appendix 1, seven out of the ten decisions were effectively implemented, while three are still in progress. The implementation rate for the decisions is therefore 70 per cent.
- 2.3 The non-completed decisions are

- a) the signature of the Management Service Agreement by the members. The Project Document and the MSA must be signed by the ICAO Secretary General, the ASECNA Director General and the Steering Committee Chairperson prior to their dissemination to members and the last signature was obtained in August 2023.
- b) The organization of a PANS-OPS oversight workshop.
- 2.4 Finally, the draft report of SC/8 was submitted to all members and partners, and their comments were captured. The missing amendment is the venue of SC/9, which is now Togo instead of Namibia.

3. **ACTION BY THE MEETING**

- 3.1 The Steering Committee is invited to:
 - a) Take note of the status of implementation of the SC/8 decisions;
 - b) Approve the report of the SC/8 meeting; and
 - c) Sign the Management Service to confirm their affiliation.
