#### **EXECUTIVE SUMMARY**

This paper provides a review of the budget which was approved the 8th meeting of the AFPP steering committee (SC/8) and the actual expenditures and contributions recorded since then. It also provides an overview of the arrears for annual membership fees, service fees and training fees.

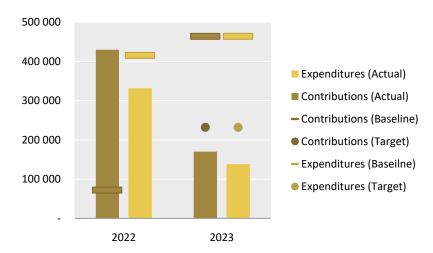

#### 1. **INTRODUCTION**

- 1.1 During its 8th meeting, the steering committee of the AFPP reviewed and approved the project document for Phase III, which included the corresponding budget.
- 1.2 The present paper provides a review of this approved budget and the related expenditures and received contributions for the period from 1 January 2022 to 30 June 2023.
- 1.3 Unless explicitly stated otherwise, all amounts in this paper are given in United States dollars.

#### 2. **DISCUSSION**

#### 2.1 Approved Budget (SC/8) vs. Actuals



2.1.1 The figure above shows a comparison of the approved baseline (and for the current year the corresponding target<sup>1</sup>) with the actual expenditures and received contributions for the period from 2022 to 2023 as at 30 June 2023<sup>2</sup>. The corresponding figures by category are provided in the table below.

#### 2.1.2 The review of the figures leads to the following main observations:

a) In 2022, the expenditures were 20 per cent below the baseline, mainly due to savings made for personnel (see SC9/23-WP3.1) and related savings due to mission travel which was not carried out. The received contributions were about six times as high as the baseline (which was low due to the surplus of funds carried over from previous

<sup>&</sup>lt;sup>1</sup> The target corresponds to the amounts which should have been spend/received at the status date with regard to the baseline. For instance, if the baseline includes an amount of \$12,000 to be spent equally throughout the year 2023, i.e. \$1,000 each month, the target as at 30 September 2023 would be (9/12)\*\$12,000 = \$9,000. The target values for years prior to 2024 are the same as the baseline values; for future years, they are not applicable.

- years). As a result, the project had a fund balance of about \$440,000, which was carried over to 2023.
- a) In 2023, the expenditures as at 30 June should correspond to 50 per cent of the baseline. The actual expenditures however are substantially less. The difference is due to, the postponed deployment of local support staff and flight procedure consultants, related mission travel that could not be carried out and reduced administrative fees (which are included in 'Miscellaneous') as a result of these savings.
- b) The received contributions for 2023 as at 30 June are also below the baseline, however less than the expenditures. The amount of received contributions exceeds the expenditures by about \$30,000.
- 2.1.3 The financial status reports for December 2022 and June 2023 are provided in Appendices 1 and 2, respectively. A more detailed review is provided in Appendix 3.

#### 2.2 Current Fund Balance

2.2.1 As shown in the table above, the expenditures during 2022 and the first six months of 2023 exceed the received contributions by close to \$130,000. Given the project balance of about \$343,000 on 1 January 2022, the balance as at 30 June 2023 is close to \$473,000.

### 2.3 Status of Payment Requests

- 2.3.1 ICAO issues payment requests for annual membership fees, services delivered by the AFPP, such as assistance with the design of flight procedures, and training fees, for the participation of States and administrations which are not Active Members of the AFPP.
- 2.3.2 The outstanding amounts by category as at 15 October 2023 are shown in the table below.

## 3. **CONCLUSION**

- 3.1 The project budget which was approved during SC/8 was not fully implemented as planned until June 2023. The differences between the baseline and the actuals are mainly due to the delayed recruitment of the local support staff and the flight procedure designers.
- 3.2 As at 30 June 2023, the project has a balance of close to \$473,000, while the arrears amount to slightly over \$800,000.
- 3.3 The Steering Committee meeting is invited to take note of the information presented in this paper.
