REVIEW AND UPDATE OF THE DRAFT AFPP STRATEGIC ACTION PLAN

(Presented by the AFPP Manager)

SUMMARY

This paper provides a summary of the AFPP Strategic Action Plan that was developed by the AFPP in reference to AFPP SC/1 Dec04b and obtain the approval of the AFPP Chairperson. The summary is intended to present the main points of the AFPP Strategic Action Plan to the AFPP SC Members.

Action by the Steering Committee is indicated in item 3.

1. INTRODUCTION

- 1.1. In reference to the AFPP SC/1 Dec04b "The AFPP is requested to develop, by 1st March 2015, a Strategic Action Plan with clear objectives and consistent with the AFPP Programme Document, for expeditious implementation of PBN to ensure that all African States implement PBN approach procedures by the end of 2016 in accordance with Assembly Resolution A37-11, and have the relevant activities of this plan reflected in the 2015 work Programme", a Strategic Action Plan for the AFPP has to be developed.
- 1.2. The Plan would include an implementation framework with clear steps and tasks in order to assist States develop and implement appropriate PBN action plans.
- 1.3. The AFPP should identify available or possible implementation support from industry partners and other stakeholders, and coordinate with such entities as necessary.

2. **DISCUSSION**

- 2.1. To meet the goal of the AFPP SC/1 Dec04b, the Strategic Action Plan was developed to be consistent with the AFPP Programme Document, and presented in the Attachment A.
- 2.2. The role of the National PBN Plan Manager/Coordinator is presented as an AFPP focal point for each State.

2.3. The current status of PBN National Plan development and PBN flight procedures implementation are listed.

- 2.4. The targets for PBN flight procedures implementation in Approach (RNP Approach) are detailed for the years 2015, 2016 and 2017.
- 2.5. Through an holistic approach, actions to be conducted by AFPP are proposed regarding National PBN Implementation Plans (in collaboration with the ICAO Regional Offices), instrument flight procedures design, PBN Operations approval and Airspace design through workshops/seminars, training, support and assistance activities.
- 2.6. A performance monitoring will be provided by the AFPP in collaboration with the ICAO Regional Offices.
- 2.7. Support from industry partners and other stakeholders, as expertise provision, logistical support or donation, secondment would be provided.
