#### 1. INTRODUCTION

1.1 The Twenty fifth meeting of the AFI Planning Implementation Regional Group (APIRG/25) and the Eighth Meeting of the AFI Regional Aviation Safety Group (RASG-AFI/8) meetings were held back-to-back from 7 to 11 November 2022 in Kigali Rwanda. The AAO/SG5 meeting was held virtually from 23 to 26 August 2022. The APIRG/25 adopted twenty-one (21) conclusions and twenty-five (25) decisions.

#### 2. DISCUSSION

- 2.1 The APIRG/ 25 meeting considered the report of the AAO/SG5 meeting and adopted all the nine conclusions and four decisions from the AAO/SG5.
- 2.2 The meeting is required to review the Status of implementation of the conclusions and decisions and take action based on the continued validity or relevance of the conclusion and decisions if if any, indicate the ones that have been overtaken by events or need to be adopted in procedures or manuals and the ones that need to continuity of monitoring to be highlighted for



further action by the subgroup.

2.3 The meeting will note that reporting on status of implementation is a challenge and the need for States and Organizations to do so is highly encouraged. The list of Draft conclusions adopted by APIRG/25 and the Status is attached to this paper as appendix A.
