1. INTRODUCTION

- 1.1 The sixth edition of the GANP was endorsed at the 40th ICAO Assembly in September 2019. The resultant framework aimed to ensure that the aviation system will be maintained and enhanced and that barriers to future aviation efficiency and environmental gains can be removed at a reasonable cost.
- 1.2 Although the GANP has a worldwide perspective, all modules are not required to be applied in every State and Region. ASBU methodology allows the flexibility to implement modules based on specific operational requirements.

2. DISCUSSION

- 2.1 Following the assignment of APIRG, the identification of applicable ASBU elements in the areas of AOP, ATM, and SAR was conducted during the 5th meeting of the AAO subgroup held virtually from 23 to 28 August 2022. The outcomes of that identification was submitted to the 25th meeting of APIRG from 7 to 11 November 2022 in Kigali, Rwanda.
- 2.2 APIRG/25 Decision 25/10 resolved the adoption of the ASBU elements applicable to the ESAF and WACAF regions identified by the AAO subgroup in the areas of AOP, ATM, and SAR.
- 2.3 In order to monitor the status of the implementation of ASBU elements applicable to

ESAF and WACAF regions, APIRG/25 Conclusion 25/11 requested States to use the dedicated data collection template, attached as Appendix A to this paper and report quarterly to the ICAO regional offices on the planning and implementation status of these elements.

2.4 Since the tenure of the 25th meeting of APIRG, the ICAO Regional Offices did not receive any report from States as requested. The Regional Offices coordinated directly with States to collect information on the status of the implementation. The status of implementation of ASBU elements applicable to the ESAF and WACAF regions in the areas of AOP, ATM, and SAR, as identified by the Regional Offices, is presented respectively in Appendix B and C of this paper.
