# Annex 9 – Facilitation Regulatory Framework on AAVF

## Std. 8.42

State of occurrence and adjacent States to facilitate temporary entry of family members of victims

## Std. 8.43

State of occurrence and adjacent States to facilitate temporary entry of authorized representatives of the aircraft operator

## RP 8.44

Recommends the State of occurrence and adjacent States not require other travel documents than passport or emergency travel document

## Std. 8.45

States to arrange to issue emergency travel documents

# Annex 9 Facilitation Regulatory Framework AAAVF

## RP 8.46

States to extend all necessary assistance to family members or operators, such as repatriation of human remains, transportation and customs formalities

## Std. 8.47

States to establish legislation, regulations and/or policies in support of assistance to aircraft accident victims and their families

## RP 8.48

States should ensure that each aircraft or airport operator develop appropriate plans to provide timely assistance to aircraft accident victims and their families

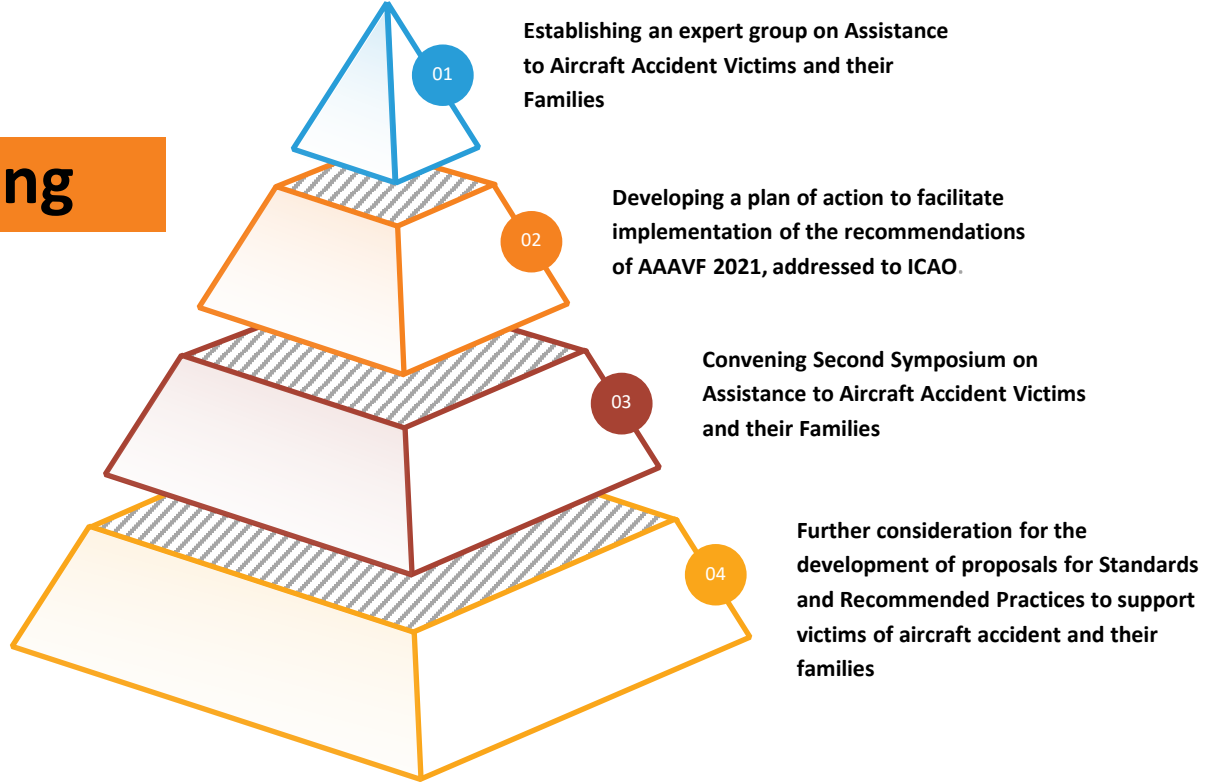

# □ Assistance to aircraft accident victims and their families (AAAVF) – Annex 9 SARPs

The State of Occurrence of an aircraft accident and adjacent State shall make arrangements to facilitate the entry into their territory on a temporary basis:

- 👤 Family members of victims (**Std. 8.42**)
- 👤 Authorized representatives or alliance partner of the aircraft operators (**Std. 8.43**)



## □ AAVF – Annex 9 SARPs

### Travel documents:

☞ *Should not required any other TD than a passport, or an emergency TD issued specifically (RP. 8.44)*

☞ *Expedite the issuance of entrance visas, if required (RP. 8.44)*

☞ *Issue emergency TD, if required, to their nationals who have survived the accident (Std. 8.45)*





## □ AAVF – Annex 9 SARPs

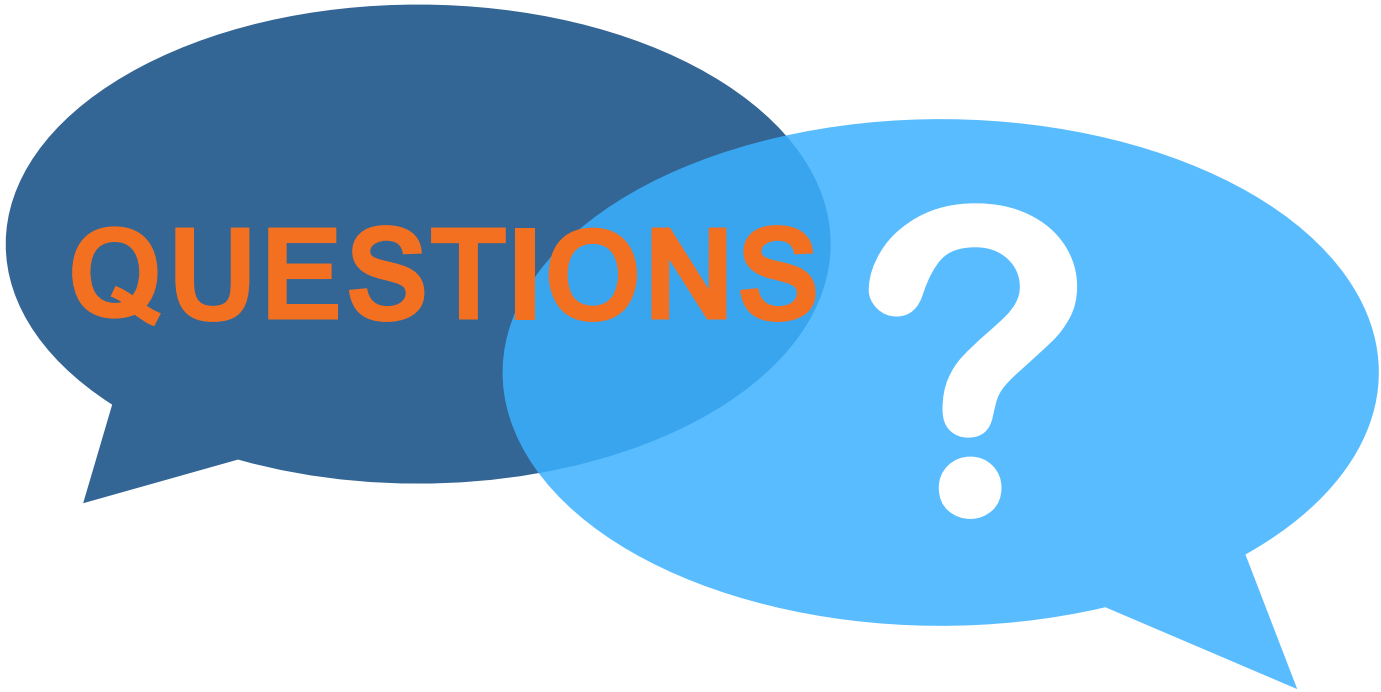
### Extend all necessary assistance:

→ In repatriation of human remains (**Std. 8.46**)



### Family assistance plans:

- ➔ Establish legislation, regulations and/or policies in support of assistance to aircraft accident victims and their families (**Std. 8.47**)
  - Doc 9998: “ICAO Policy on Assistance to Aircraft Accident Victims and their Families”
  - Doc 9973: “Manual on Assistance to Aircraft Accident Victims and their Families”
  
- ➔ *Each aircraft or airport operators, as appropriate, develop plans to provide timely and effective AAVF (RP. 8.48)*
