Subject: Invitation to the AFCAC/ICAO Joint Workshop on PBN Implementation

(Dakar, Senegal, 24-26 June, 2014)

Action Required: Reply to confirm participation by 31 May 2014

Dear Sir/Madam,

During the APIRG/19 meeting, which was held in Dakar from 28 to 31 October 2013, AFCAC and the RECs were requested by APIRG to provide assistance to States in the implementation of the Action Plan for the AFI Regional Air Navigation System.

AFCAC, as part of its own mission to assist its member States, included in its Program of Activities for 2014, a Seminar / Workshop on the implementation of PBN at the national level, to foster the execution of the PBN Action Plan in the AFI Region.

In this regard, we have the honour to inform you that the African Civil Aviation Commission (AFCAC) and the International Civil Aviation Organization (ICAO) have agreed to conduct a Joint Workshop on National Performance Based Navigation (PBN) implementation Plan for the benefit of States in the African region. The Workshop will take place in the Conference Room of the AFCAC Headquarters in Dakar, Senegal, from 24 to 26 June 2014 and your State/Administration/Organization is cordially invited to participate.

This Workshop is being organized pursuant to the necessary implementation of PBN Plan by African States and expediting the execution of PBN in the African region to meet ICAO requirements on PBN through APIRG/18 conclusion calling on States to develop their National PBN Implementation Plan and GNSS/PBN TF/4 Conclusions 4/02 on National PBN Programme Manager/Coordinator and 4/03 on National PBN Implementation Plan.

The PBN Implementation Workshop is intended to assist States/Administrations in enhancing their PBN Implementation Plans and move forward with actual PBN executions. The Workshop will also provide updated information regarding global PBN activities and how PBN can be an enabler for enhancing ATM operations.

The PBN Implementation Workshop is supported by the ICAO African Flight Procedure Programme (AFPP) Office which will start its operations on 2 June, 2014 in its offices in Dakar, Senegal.

During the Workshop, participants will be given the appropriate tools and knowledge for the drafting of a National PBN Implementation Plan, with assistance from African FPP facilitators and will develop a list of short-term action items aiming to enhance their existing PBN Implementation Plans and advance their on-going PBN implementations
