**Subject: Invitation to CNMC/9, SAT/FIT/14 and SAT/24 meetings
(Luanda, Angola, 03-07 June 2019)**

Action required: To reply not later than 20 May 2019

Sir/Madam,

I have the honor to inform you that upon the kind invitation of **Empresa Nacional de Exploração de Aeroportos e Navegação Aérea (ENANA)** supported by the Angola Civil Aviation Authority, the ICAO Regional Offices in Dakar, Lima Nairobi and Paris will organize the following events in Luanda, Angola to which your Administration/Organization is invited to participate:

- a) Ninth Meeting of the CAFSAT Network Management Committee (CNMC/9) and Fourteenth Meeting of the FANS I/A Interoperability Team (SAT/FIT/14), 3 to 4 June 2019, and
- b) Twenty-Fourth Meeting on the improvement of Air Traffic Services over the South Atlantic (SAT/24), 5 to 7 June 2019.

The main objectives of the meetings are to explore ways and means to further enhance the provision of air traffic services in the South Atlantic through the established interregional coordination mechanism.

In these meetings the participants will have the opportunity to review important aspects as the performance of the CAFSAT VSAT network and to follow up on the implementation of CAFSAT modernization (CNMC/9), to review the implementation of ADS-C CPDLC and the monitoring performance of FANS services in the SAT Region (SAT/FIT/14); to follow up on the implementation of AORRA air space, evaluation of procedures in the AORRA, review the ATS contingency plan, the implementation of RNP4 in the EUR SAM corridor and the improvements of the CNS system to ensure the capacity, efficiency and safety in the SAT Region (SAT/24).

The events are mainly addressed to Air Traffic Management (ATM) and Communication, Navigation and Surveillance (CNS) experts, and representatives of international organizations involved in the planning, implementation, operation and maintenance activities in the SAT Region. The meetings will be conducted only in the English language.
