1. Introduction

- 1.1. The revision of the project has been undertaken to ensure its ability to assist States in developing sustainable capability for oversight MET services and addressing long standing challenges faced by States in MET field.
- 1.2. The project is open to the all AFI States and will be implemented on the basis of the project work plan starting in August 2021 and ending in July 2023.
- 1.3. Taking into account the context of Covid-19 Pandemic, and in the view of reducing the project cost, a blinded work plan has been developed to achieve the project deliverables.

2. Discussion

- 2.1. The Project Preliminary Schedule project run from August 2021 to July 2023. The work plan comprises 16 activities to be achieved during the project life time in order to provide the following deliverables 4 deliverables:

 - Generic regulations, guidance material, operational procedures, technical tools, QMS related guidance and procedures

- 2.4. The deliverable 3 is supported by 3 planned activities for the following deliverables:
 - Certification of States MET Services Providers QMS and Surveillance
- 2.5. The deliverable 4 is supported by 1 planned activity /State for the following deliverables:
 - Project exit wrap up to provide guidance for maintaining and continuous improvement of the system
