### UAE NATIONAL AIRSPACE ADVISORY COMMITTEE (NASAC)

#### • Objectives;

- Communication, collaboration and cooperation which should result in benefits to airspace management and air traffic management.
- ✓ Higher level of safety, national security and increase airspace capacity.

#### • Functions;

- ✓ Recommend initiatives to provide a high quality service.
- ✓ Coordinate with airspace users.
- ✓ Review the impacts of civil and military operational requirements.
- ✓ Maintain close cooperation with military authorities.



### FUA

- airspace is not designated as purely civil or military, but rather as a continuum in which all user requirements are accommodated to the greatest possible extent.
- Increase flight economy by enabling direct flight
- Increase airspace capacity by providing more ATS routes during a specific time period;
- Reduce ATC workload by enhancing ATS route network and associated sectorisation;
- Provide more flexible and closely airspace reservation in line with military operational requirements.
- Military Authorities involvement in airspace planning and management process.
- Several Restricted airspaces were released to civilian use and the UAE military have access to it and when required to be used.
