Subject: **Virtual Special Meeting of the SAT Group**

Action required: *Please reply not later than 7 July 2021*

Sir/Madam,

I wish to refer to the Twenty-Fourth Meeting for the improvement in the provision of air traffic services in the South Atlantic (SAT/24) Conclusion 24/08 on SAT Vision, CONOPS and Implementation Plans, which states inter alia, "That,

- a) The SAT Group identify initiatives in the NAT Vision 2030 project in order to harmonize operations, infrastructure and programmes with the aim of achieving a safer, more efficient, environmentally responsible and more cost effective ATS service over the entire Atlantic Ocean;
- b) Reconstitute the SAT Study Group on the Improvement of the Airspace Structure to coordinate the development and adoption of a SAT Vision document, Concepts of Operation and an implementation roadmap;
- c) Rename the SAT Study Group on the Improvement of Airspace Structure (IAS/SG) to SAT Atlantic Implementation Management Group (SAT IMG) and request the Secretariat to align its Terms of Reference and work programme accordingly; and
- d) SAT Group assigns the responsibility for PBCS implementation in the SAT area, beginning with the EUR/SAM corridor as a priority, to the IMG.

I wish further to refer to the Summary of discussions from the Second ICAO Atlantic Coordination Meeting (ACM/2), hosted by the Director Air Navigation Bureau (D/ANB) in Montreal, Canada from 18 to 20 February 2020. It was agreed to apply a three-level approach (Level-1 SAT with high-level participation, Level-2 IMG/SMG coordination groups, Level 3 technical groups to support implementation for IMG and three regional RMAs plus LHD groups to support safety relevant aspects for SMG). The meeting agreed to the following implementation plan:

- i. ASECNA and France to submit these proposals (structure, concept of operations (CONOPS), vision document) and related Terms of Reference (ToRs) to SAT – IMG – SOG/SMG by 8 May 2020. ICAO Dakar to distribute the new material to all SAT stakeholders for approval by SAT/25 (June 2020);
- ii. ICAO Dakar to transmit these new proposals and ToRs to GREPECAS via Mexico and Angola and South Africa vis Nairobi before SAT/25 meeting;
- iii. SAT to implement the new proposals and ToRs before the end of 2020.

You will recall that the action items in (i) and (ii) above have been completed; however, item (iii) is still pending.
