

#### Annex 15 states that ...

2.1.4 Each Contracting State shall ensure that the aeronautical data and aeronautical information provided are of required quality...

2.1.5 Each Contracting State shall ensure that formal arrangements are established between originators... in relation to the timely and complete provision of aeronautical data and aeronautical information.




#### Annex 15 states that ...

3.3.1 Material to be issued as part of an aeronautical information product shall be thoroughly checked before it is submitted to the AIS in order to ensure that all necessary information has been included and that it is correct in detail.

3.3.2 An AIS shall establish verification and validation procedures which ensure that upon receipt of aeronautical data and aeronautical information, quality requirements are met.





#### Annex 15 states that ...

3.6.1 Quality management systems shall be implemented and maintained encompassing all functions of an AIS... The execution of such quality management systems shall be made demonstrable for each function stage.

# Annex 15 to the Convention on International Civil Aviation Aeronautical Information Services Sixteenth Edition, July 2018 INTERNATIONAL CIVIL AVIATION ORGANIZATION

#### Annex 15 states that ...

6.3.2.2 A NOTAM shall be originated and issued:

- whenever the information to be distributed is of a temporary nature and of short duration, or
- when operationally significant permanent changes or temporary changes of long duration are made at short notice, except for extensive text and/or graphics.

6.3.1.3 Temporary changes of long duration (three months or longer) ... shall be published as AIP Supplements.

## The AIS Manual provides that ...


3.1.2.3 Information that qualifies for publication as an AIP amendment should not be promulgated as NOTAM, since those address operationally significant changes only.

States should establish efficient processes for the publication and dissemination of AIP amendments to avoid issuing NOTAM on information that are not considered significant to flight operations.

3.1.3.4 If the information meets the requirements for publication as an AIP SUP, a NOTAM should not be issued since it did not qualify as operationally significant.


To avoid issuing NOTAM..., States should establish processes for quick publication and dissemination of AIP SUPs.

This helps to minimize the proliferation of NOTAM that are not operationally significant.

#### TEMPORARY CHANGE of LONG DURATION (3 months or longer)



## Issue a NOTAM with long duration... if information:

- causes a temporary change of long duration to the AIP
- is operationally significant, and
- was received at short notice.

However, NOTAM shall be published as AIP SUP and cancelled within three months (see next slide)!





#### TEMPORARY CHANGE of LONG DURATION (3 months or longer)




#### PANS-AIM states that ...

6.1.4.5 Within three months from the issuing of a temporary NOTAM of long duration, the information contained in the NOTAM shall be included in the AIP SUP.



#### PERMANENT CHANGE



#### PANS-AIM states that ...

6.1.4.4 Within three months from the issuing of a permanent NOTAM, the information contained in the NOTAM shall be included in the aeronautical information products affected.

#### PANS-AIM states that ...


6.1.4.6 When a NOTAM with estimated end of validity unexpectedly exceeds the three-month period, a replacement NOTAM shall be issued, unless the condition is expected to last for a further period of more than three months; in this case, an AIP SUP shall be issued.

- NOTAMR: **412** of 564 (73%)
- Repetitive NOTAM Replacement



Please don't use "Cheap Trick"





## **Repetitive NOTAM replacements**

- clearly in violation of the original intent of NOTAM
- not compliant with PANS-AIM procedures (6.1.4.6)
- not counted in NOTAMETER

- Hand Amendment NOTAM: 24 (10% of total NOTAM)
- Old NOTAM: 2 (8% of total Hand AMDT NOTAM)
- Very Old NOTAM: 20 (83% of total Hand AMDT NOTAM)

6.1.3 Specifications for AIP Supplements

When an error occurs in an AIP Supplement or when the period of validity of an AIP Supplement is changed, a new AIP Supplement shall be published as a replacement.



## **NOTAM** that shall not be issued...

- Information that shall not be notified by NOTAM are clearly stated in Annex 15 (6.3.2.4)
- A NOTAM should not be issued since it did not qualify as operationally significant
- If you get a request to issue a NOTAM for the information as stated in Annex 15, educate the originator and do not publish the NOTAM.





## Example ...

Publication resolution: 1sec (however, AIP resolution is greater than required publication resolution)

Accuracy: 30m

• Distance: 13.7m (Geo Calc)





#### The AIS Manual states that ...

6.3.7.3 ... Any NOTAM using EST must be cancelled or replaced before the date-time specified in Item C).

Failure to cancel or replace a NOTAM using EST implies that the NOTAM will continue to be promulgated for an indefinite period of time.









#### Annex 15 states that ...

5.2.4.2 An AIC shall not be used for information that qualifies for inclusion in AIP and NOTAM.

Aeronautical Information Circular (AIC). A notice containing information that does not qualify for the origination of a NOTAM or for inclusion in the AIP, but which relates to flight safety, air navigation, technical, administrative or legislative matters.





