#### 1. INTRODUCTION

- 1.1. The Decision 24/28 of APIRG/24 endorsed the AFI Volcanic Ash Exercise Operational Instructions (OPINS) and Directives to guide the planning and conduct of the volcanic ash exercise.
- 1.2. In accordance with the provision of the OPINS, the volcanic ash exercise should be conducted every two years in the AFI Region.
- 1.3. The 2023 exercise will be led by the Democratic Republic of Congo as Exercise Leader under a scenario of eruption of the volcano Nyiragongo, Goma refered 223030.

# 2. DISCUSSIONS

- 2.1. The Exercise Leader should develop a clear scenario of the VA exercise in collaboration of all the stakeholders, specially the AFI VAAC of Toulouse.
- 2.2. The volcano subject of the exercise should be identified as follows:

• Position: S01.52 S E29.25

Area: Goma, DRC

- 2.3. The Exercise Leader should develop the chronological list of the actions to be undertaken before and during the exercise as per the template provided in Appendix A to this WP.
- 2.4. The scenario messages include VONA, VAA/ VAG, VA Exercises SIGMET, NOTAM, AIREPs, exercise tele-conferences/web-conferences, e-mail exchanges and instant messaging chats, etc.
- 2.5. The meeting may discuss the 2023 exercise schedule as adopted by PIRG/25 meeting and provided in the Appendix A to this WP.
