Adoption of the Agenda for APIRG/23 and RASG-AFI/6 Joint Sessions

SUMMARY

This working paper presents the Provisional Agenda for the 23rd Meeting of the AFI Planning and Implementation Regional Group (APIRG/23) and the Sixth Meeting of the Regional Aviation Safety Group for the AFI Region (RASG-AFI/6) Joint Sessions for discussion and adoption.

Objectives	

1. INTRODUCTION

- 1.1. The meeting may recall that during the APIRG/22 and RASG-AFI/5 meeting a presentation was made on the PIRGs/RASGs enhancement strategy based on the ICAO Council Decision 210/4, and the outcome of the Global PIRG/RASG Coordination Forum held in Montreal, Canada in 2017. Presented was the proposed evolution and timelines towards an integrated approach addressing organizational challenges, infrastructure, operational risks and performance measurement.
- 1.2. In this regard, the format of APIRG/22 and RASG-AFI/5 meetings including joint sessions marked a transition from the back-to-back approach applied by the AFI Region since 2012 (combined with a DGCA meeting in 2013) to the proposed integrated approach.
- 1.3. The APIRG/22 and RASG-AFI/5 meeting, therefore, requested the APIRG/RASG-AFI Task Force (ARC-TF) to conduct an in-depth analysis and develop proposals for the structural changes and timelines for the implementation of the integrated approach in the AFI Region. Details of the proposed structural changes required for the implementation of the enhancement strategy in the AFI Region are presented under the agenda item "Implementation of Council-approved Terms of reference for PIRGs and RASGs", including the joint sessions whose Tentative agendas are discussed in the WP.
- 1.4. This paper therefore presents the Tentative Agendas for the Twenty-Third APIRG (APIRG/23) and RASG-AFI/6 joint meeting sessions.

2. DISCUSSION

- 2.1 The Tentative Agenda for the APIRG/23 and RASG-AFI/6 meeting joint sessions, prepared by the Secretariat, were presented to APCC and RASC for discussion and endorsement. This was done in line with the Air Navigation Commission's recommendation for a uniform approach to the formulation of the agenda for PIRGs and RASG Meetings, The ARC-TF/3 adopted the agenda as endorsed by the APCC and RASC.
- 2.2 The Tentative Agendas for discussion by the APIRG/23 and RASG-AFI/6 meeting joint sessions are provided as an **Attachment** to this working paper.
