State Safety Program Working Group

The State Safety Program working Group is established to support the CASIP Steering Committee in the development and monitoring the implementation of Detailed Implementation Plans (DIPs) related to identified deficiencies and improve the status of implementation of State Safety Programme (SSP) and Safety Management System (SMS) in Africa.

The working Group shall develop DIPs related to State Safety Program (SSP):

- · strengthening of States' Safety Oversight capabilities through the collaboration and support of
- African Regional Safety Oversight Organizations(s) (RSOOs)
- · establishment of a Go Team in order to conduct assistance missions to States to address specific
- needs (SSP/SMS) conduct of SSP gap analysis and completion of detailed SSP assessment.

Training, Capacity Building, & Improvement Monitoring Working Group

Based on recommendations drawn from SIRM, Safety reports and other working groups such as RCG, resources shall be directed towards building capacity of relevant organizations to enhance safety performance in the region through delivery of safety training and workshops. The group will establish a mechanism to monitor all progress made as a benefit from the training and capacity building. As part of the monitoring, it is important to ensure:

- . Training is afforded to the relevant personnel with the direct responsibility for safety enhancement
- . Training is aimed at systematic performance improvement as opposed to individual needs
- . Beneficiary organizations demonstrate implementation and tracking of continuous improvement

Safety Issues Review Group - Africa

Composition and participation at SIRG;

Participation shall be open to safety professionals from airlines, manufacturers, ground service providers and airports, air navigation service providers as well as invited subject matter experts from academia, industry associations and any other relevant industry stakeholders. The meeting will be held under Chatham House Rule with IATA as Secretariat. The SIRM shall comprise of two (2) dedicated Safety Issues Meetings arranged on a rolling annual basis, categorized by sub region.
