1. INTRODUCTION

1.1 The RASG-AFI Steering Committee (RASC) was established to guide the work of the Group and to ensure that the Safety Enhancement Initiatives (SEIs) identified by the region are implemented in a timely, effective and efficient manner. In this regard, the RASC was mandated, amongst other things, to propose an Annual Work Programme in addition to ensuring that the activities of the Group are properly coordinated.

2. DISCUSSIONS

- 2.1 RASG-AFI activities require RASC to exercise flexibility, at its discretion, on the contents and frequency of its activities whilst considering, the logical chronology and sequence for effective implementation. Therefore, the proposed 2024 activities were developed in view of these objectives.
- 2.2 The proposed 2024 Activities cover those of the RASC, the Safety Support Teams (SSTs), the Annual Safety Report Team (ASRT), and RASG-AFI meetings. With the development of the Regional Aviation Safety Plan for Africa-Indian Ocean (AFI-RASP 2023-2025 Edition); the key focus areas will include but not limited to the implementation of the Safety Enhancement

Initiatives (SEIs) identified in the AFI-RASP; and the assistance to be provided to States by the Regional Offices and other stakeholders to develop and implement their National Aviation Safety Plans (NASPs) aligned with the AFI-RASP and the GASP.
