1 INTRODUCTION

- 1.1 The current SAT handbook contains provisions regarding the structure of SAT which is made of three main bodies namely SAT Steering Group (SAT SG), SAT Safety Oversight Group (SAT SOG), and SAT Implementation Management Group (SAT IMG). Several project teams are established under the different bodies to carry out study, planning and implementation activities as guided by the SAT SG.
- 1.2 The SAT bodies are composed of SAT member States, ANSPs, IATA, International organizations, Industry stakeholders and ICAO Regional Offices in Dakar, Lima, Mexico, Nairobi and Paris.
- 1.3 The access to details of SAT members remains a challenge due to lack or incomplete information available at the secretariat.

2. DISCUSSION

- 2.1 Although the SAT members and observers are cited in the handbook, some key information are yet to be available, notably the identities and contact details of members and observers as well as the details of focal points.
- 2.2 The effective communication of information and data between SAT members relies on readily accessible detailed information concerning all SAT stakeholders. To satisfy this need, some forms have been developed by the secretariat to collect and collate information from the SAT stakeholders.
- 2.3 Information collected and processed will be appended to the SAT handbook in electronic versions and made available to all eligible persons on ICAO secure portal.
- 2.4 The forms developed include, the **Appendix A** "the list of SAT States with contact details and focal points details", the **Appendix B** "the list of ANSP with associated States or FIR, contact details and focal points", the **Appendix C** "The list of airspace users, contact details and focal points", the **Appendix D** "the list of observers, contact details and focal points", the **Appendix E** "the list of ICAO Regional offices, contact details and focal points".
- 2.5 It is suggested that amendment to the list be done without necessarily amending the SAT handbook, however the table of records of amendment shall be updated accordingly in SAT Doc 001.
