1. AVIATION ENVIRONMENTAL SYSTEM (AES)

Data collection and Monitoring

For data collection, CAA established the obligation with the Instruction $n^{\circ}01/AEC/2023$ for national airline operators to submit (by 15th of each month) data related to CO2 emissions in order to monitor the implementation of the action plan to reduce CO2 emissions. This Instruction is applicable to all national airline operators engaged on the transport of passengers, cargo and mail on commercial flights (domestic and international).



Submission of Monthly CO2 Reports to ICAO

According to the Instruction nº01/AEC/2023, the CAA submits the report of CO2 emissions to ICAO on monthly basis. The emission report for January 2023 shows that there were 37 international flights with a CO2 emission of 1,040 (t), RTK of 1.115.548 (tkm), fuel burn 411,387 (l), with and fuel efficiency of 0.369. However, compared with to February emission report, there were 32 international flights with a CO2 emission of 909 (t), RTK of 936 334(tkm), fuel burn 359 545 (l), with and fuel efficiency of 0.384.

2. Mitigation Measures – Implementation Progress

Measures already in place

MM3 - Publication of authorization for the planning of direct routes in the FPL in SAL FIR (Aircraft can fly in SAL FIR from entry point direct to exit point, without intermediates point).

 Completed. The authorization was published for planning direct routes in the FPL in SAL FIR (Aircraft can fly in SAL FIR from the direct entry point to the exit point, with no intermediate point)

MM4 - Implementation of PBN SID and STAR procedures at Praia and Sal international airports.

 Completed. Procedures approved by the CAA, waiting for AIP publication scheduled for October 2023

MM5 - Design and implementation of CCO procedures at all international airports (2019-2022).

Completed. Procedures CCO Praia and Sal airport to be published.
 However, São Vicente and Boa Vista airport still without procedures.

MM6 - Design and implementation of CDO procedures at all international airports (2019-2022).

Completed. Procedures CDO Praia and Sal airport to be published.
 However, São Vicente and Boa Vista airport still without procedures.

2. Mitigation Measures – Implementation Progress

Measures that started as a result of the project

MM8 - Full replacement of conventional lighting by LED in buildings and facilities of all the international airports ASA and CVH started the process of replacing conventional lighting by LED.

MM11 - Replacement of obsolete AC equipment (R22) with modern and more efficient equipment in all the international airports of Cabo Verde (2021-2025)

• In the process to replace all obsolete AC equipment at all airports.

MM12 - Placement of motion sensors for lighting control in all WCs at the international airports São Vicente and Boa vista Airport.

• Completed in Boa Vista airport and 80% in São Vicente Airport.

MM13 - Change the internal procedures regarding disembarkation with the aid of buses, prioritizing the embarkation on foot by managing the stands closest to the terminals- CVH

 Measure in place since December 2022 by Cabo Verde Handling (CVH) in partnership with ASA.

MM15 - Acquisitions of Ground Support Equipment cleaner fuels, namely electric GSE

 CVH Purchased 2 electric forklifts for Praia and Sal airport and intend to buy 3 electric tractors in 2023.

2. Mitigation Measures – Implementation Progress

Measures that are scheduled to be implemented in the short term

MM1 - Conduct a feasibility study to assess the potential alternative fuel in Cabo Verde.

- Ministry of Energy and CEDEAO funding have in place a study to develop a Nacional Bioenergy Action Plan for Cabo Verde. This study includes potential alternative fuel in the country.
- **MM2** RNP4 implementation in the Europe/South America (EUR/SAM) corridor.
- There will be a EUR SAM corridor meeting scheduled for April 24th to 26th in Madrid – Spain for discussion.
- **MM7** Adaptation of Taxiway B for medium/large aircraft for the São Vicente airport.
- It will start with the airport concession. The concession contract has already been signed with VINCI AIRPORT and It's currently in the transitory phase.

MM9 - Installation of photovoltaic panels in Boa Vista, Praia and São Vicente airports.

It will start with the airport concession. The concession contract has already been signed with VINCI AIRPORT and It's currently in the transitory phase.

MM10 - Wind park at Sal airport (2024-2026)

 It will start with the airport concession. The concession contract has already been signed with VINCI AIRPORT and It's currently in the transitory phase.

MM14 - Replacement of vehicles (Follow-me, VIP terminal and maintenance) by electric vehicles at Boa Vista, Praia and Sal airports.


