GENERAL INFORMATION

1. LOCATION

2. **OPENING CEREMONY**

2.1 The opening ceremony of the Seminar will be held at 1500 hours on Tuesday, 24 April 2018 at Norman Manley International Airport (NMIA), Kingston, Jamaica followed by a reception at 1800 hours at the Jamaica Pegasus Hotel. Transportation will be provided.

3. REGISTRATION OF PARTICIPANTS

3.1 Early Registration of participants and collection of the name tags will take place at the Jamaica Pegasus Hotel, Talk of the Town (venue of the meeting) between 1100 and 1200 hours on the opening day of the meeting and at the Norman Manley International Airport (NMIA) between 1400 and 1500 hours. The registration will also take place on the 25 April from 0800 to 0900 hours at the venue of the meeting. Transportation will be provided from the Pegasus hotel to the Inauguration ceremony.

4. LANGUAGE

4.1 English will be the working language. Simultaneous interpretation into Spanish will be Provided during the Seminar from 25 to 26 April 2018.

7. TRANSPORTATION

7.1 Participants are requested to arrange their own transfers from/to the Airport. Taxis are available from the airport to the hotels and the fare is normally US\$40. However, it is advisable to agree on the fare before getting into the vehicle. Enquiries may be made at the airport information desks/counters upon arrival.

CURRENCY, CREDIT CARDS AND BANKING SERVICES

- 9.1 The national currency is the Jamaican Dollar (JMD). The current rate of exchange for USD is approximately USD 1= JMD 125.521 in banks or exchange agencies. Foreign currency can be changed at banks, foreign currency bureau or hotels. Banks in major centres are open from Monday to Thursday from 0830 to 1400 hours and Fridays from 0830 to 1600 hours.
- 9.2 All major international cards are generally accepted in hotels, shops and restaurants.

WEATHER AND LOCAL TIME INFORMATION

9.3 In April, the daytime temperature in Kingston ranges from 23 °C to 28 °C, with humidity that ranges from 44% (comfortable) to 94% (very humid). Jamaica local time is UTC/GMT -5h. It is fixed across the country.

BUSINESS HOURS

9.4 Regular commercial business hours are from Monday through Saturday from 0830 to 1400 hours.

TAX AT AIRPORTS

9.5 No additional tax is collected at the airport. The taxes are included in the airfare.

TAXES AND TIPS

9.6 The tax on purchases is included in consumer prices. Tipping in restaurants is not included in the bill and is customarily 10% of the value.

VISA REQUIREMENTS

- 9.7 It is highly recommended to check the requirements early, as visa processing times can vary. For further information on entry and exit requirements, please consult the Passport, Immigration & Citizenship Agency (PICA) website http://www.pica.gov.jm/
- 9.8 For those persons who do not have a Jamaican Consulate in their State, please see below:

The Visa Unit of the PICA accepts applications for entry visas which if approved may be issued at the port of entry. In submitting an application on behalf of the affected nationals, Individuals are required to present the following:

- 1. letter from JCAA identifying the persons being invited, the purpose and length of their visit
- 2. copies of each person's passport bio-data page (passports must be valid for at least 6 months from date of travel)
- 3. address or name of hotel where they will be accommodated
- 4. flight itineraries for their return to their homeland or place of residence
- 5. evidence of immigration status in the place they are returning, if not their homeland

The aforementioned documents may be submitted in person or scanned and emailed to visajamaica@pica.gov.jm

Kindly note that the Unit requires five (5) working days for processing. Visa fees at the port of entry for nationals of the UAE is US\$350 each. Fees are payable upon arrival and must be paid in United States currency only and is accepted in cash, debit or credit card.

HEALTH

- 9.9 Participants must be in good health and have medical insurance or another type of health care plan which covers medical emergencies. Neither the International Civil Aviation Organization nor the Government of Jamaica shall be held responsible for medical expenses incurred by seminar participants.
