## REQUEST FOR ASSISTANCE THROUGH THE EUROPEAN UNION (EU) PROJECT AND VOLUNTARY PARTICIPATION IN CORSIA

I have the honour to inform you of Nigeria's decision to voluntarily participate in the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA), starting from the pilot stage in 2021. Nigeria is a strong supporter of ICAOs work in the mitigation of CO2 emission in International aviation.

The Nigerian Civil Aviation Authority (NCAA) wishes to refer to the Nigerian State Action Plan on mitigation of CO2 emissions submitted in 2015 and to inform that the action plan is currently being updated.
